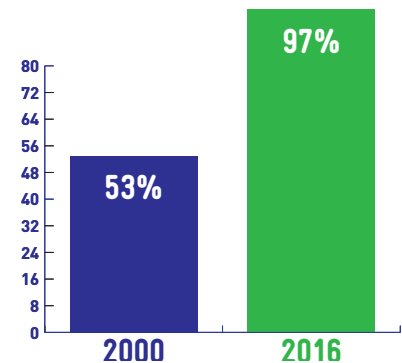
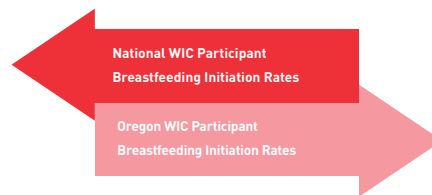
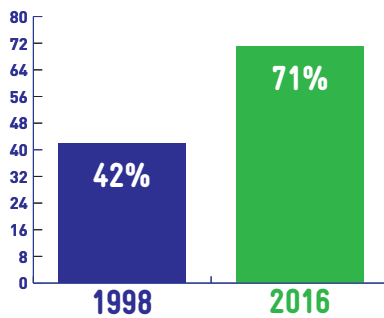

EBT STATUS

Oregon has implemented WIC EBT/eWIC statewide. All state WIC programs must transition from paper vouchers to electronic benefit transfer cards (EBT) by 2020.

WIC SUPPORTS MILITARY FAMILIES

Oregon WIC staff are trained to accept military WIC Overseas VOC and they do not count on- or off-based military housing direct payments as income.
