

Vendor Violations and Sanctions

(Effective November 25, 2025)

Definitions

Civil Money Penalty (CMP): A monetary sanction imposed as a result of a violation of state and/or federal rules.

Disqualification (DQ): Cancelling the WIC program participation of a vendor or farmer as a punitive action.

Notice of Non-Compliance (NNC): A letter notifying vendors when they commit a program violation. This notice is an explanation of the violation and a warning about repercussions of subsequent violations.

***Pattern:** Three or more findings of the same rule violation that occur within a single investigation or over the course of one or more routine monitoring(s).

Relevant Oregon Administrative Rules (OAR)

OAR 333-054-0050(1): The Authority must notify a vendor in writing when an investigation reveals an initial incidence of a violation for which a pattern of incidences must be established in order to impose a sanction, before another such incidence is documented, unless the Authority determines, in its discretion, on a case-by-case basis, that notifying the vendor would compromise an investigation.

OAR 333-054-0060(8): The Authority shall disqualify a vendor from the WIC program if they have been disqualified from the Supplemental Nutrition Assistance Program (SNAP).

OAR 333-054-0060(9): Disqualification from the WIC Program may result in a reciprocal disqualification from SNAP.
