Updated Vendor Violations and Sanctions document

The Vendor Violations and Sanctions document summarizes information in the Oregon Administrative Rules (OARs) for WIC Vendors. Oregon WIC is mailing a copy to all WIC-authorized stores with this Quarterly Update. Please replace the version you have in your store's WIC Vendor Guide with this new copy.

WIC-authorized vendors must understand WIC violations and sanctions. Non-compliance with WIC rules can lead to penalties, including disqualification from the WIC program, fines, and even loss of SNAP authorization. Vendors are responsible for the actions of their employees. Understanding program rules helps prevent mistakes that could lead to violations.

An Excel version of Oregon's Approved Products List is available online

The Approved Products List (APL) is a file of WIC-approved food UPCs and fresh produce PLUs. The APL is downloaded onto store registers nightly and runs in the background during WIC transactions.

An Excel version of the APL is posted on the Oregon WIC website as a resource. It has a tab with the complete Oregon WIC APL, a tab for Recently Added items, and a tab for Recently Removed items.

The Excel APL can be sorted by food category and filtered by brand. Use it to find WIC-approved foods in your store's inventory. This is especially useful if your store's point-of-sale system requires a WIC flag.
