CLAIMS AND BILLING UPDATE

1. **2017 Reimbursement Schedule** – ScreenWise will have the updated Reimbursement Schedule for 2017 available by the end of this month. We will post it on our website and email a copy to providers as soon as it is available. We appreciate your patience in this process.
2. **New message on provider reports** – Our provider reports have recently been updated to include a section for missing enrollments. This is usually a result of our program receiving a claim without an enrollment on file, or we could have received the enrollment but it was not complete (missing house hold income or size, date of birth, etc). We identify the patient to your clinic by using the referring provider on the claim form. If you see this in your report please send in an enrollment form as soon as possible, as patient claims are denied if they are not enrolled.

PROGRAM UPDATE

1. **Reminder** – Recently, our office has received many forms that are not the most current version. This may result both missing information and the submission of some information that may no longer be necessary. 2. **Data requests** – In partnership with our funder, the CDC, ScreenWise will be closing out breast, cervical, and cardiovascular data from the last 2 years. This results in requests for forms to our providers when our system flags something as missing. You may have already received this request. Please respond no later than **March 17th**.
