We now have the [2019 schedule of batch, PDR, and EOB dates](#) posted on our website under the [Billing and Claims] page as well as the [Updates and Resources] page. The batch dates are the day that claims are processed here at the ScreenWise Program. The PDR date is when the Provider Data Reports go out to the enrolling provider to reconcile any missing screening results while the EOB date is when the Explanation of Benefits go out to both enrolling and ancillary providers to reconcile their claims.
