

## ScreenWise Program Update: October 2019

---

### **Billing Reminder for ENROLLING Providers:**

All *Enrolling Providers* can file for and be reimbursed **\$33.45** for enrolling a patient and submitting the paperwork and results to ScreenWise. The Current Procedural Terminology or CPT code for claiming the ScreenWise reimbursement is **99080**, (or you may use **RESLT** on the in-house claim form) located on the ScreenWise website at [www.healthoregon.org/screenwise](http://www.healthoregon.org/screenwise).

On page 1 of [the list of CPT Covered Services](#), (located under [Billing and Claims](#) on the website), the description for 99080 is “Breast and Cervical Screening Results Coordination.” This includes:

- enrolling the patient into ScreenWise
- submitting the Intake Packet
- submitting the Results and Outcome forms for each patient

When you file the claim for CPT code 99080, you may use any date of service that falls within the year of the patient’s enrollment. To keep it simple, most providers use the same claim and date of service as the patient’s first office visit. You can even use the same claim for both the office visit and the 99080!

If you have a patient younger than age 50 that was enrolled for diagnostic services only, you may still file for the CPT code 99080, since you will still be submitting the results to ScreenWise.

If you are an *Enrolling Provider* performing ancillary services such as colposcopy, but the patient was enrolled through a different enrolling provider, the CPT 99080 would not apply to your agency and will not be reimbursed.

### **Announcement:**

The ScreenWise program (breast and cervical cancer screening) has a funding, learning, and networking opportunity for FQHC’s to support quality improvement (QI) work to improve breast and cervical cancer screening at their clinics using a learning collaborative model. The ScreenWise Evidence-Based Interventions (EBI) Learning Collaborative will bring together 6 FQHC’s starting in January 2020 with a focus to increase breast and cervical cancer screening rates and address other aligned healthcare priorities, such as the new CCO adolescent HPV immunization metric.

The Evidence-Based Interventions are those outlined in the CDC’s Community Guide, and can include:

- patient and provider reminders
- provider reminders, assessment, and feedback
- reducing structural barriers
- reducing out-of-pocket costs
- community outreach and other avenues for patient education and navigation

The FQHC’s will receive \$10,000 through the Oregon Primary Care Association (OPCA) to support their participation and improvement efforts. Deadline to apply is October 25<sup>th</sup>.
