Welcome, Introductions and Review of Agenda

Supporting Document: SBHC RAC Agenda – 11.2025

- Introductions
- The goal of the meeting is to review paperwork SPO will submit for rules change process. Update OARs to reflect changes to Standards from modernization process.
- SPO reviewed the meeting agenda, meaning of serving on RAC and limitations, overview of SBHC Standards revision process, and different paperwork components sent to attendees. (Agenda, 333-028 Notice of Proposed Rulemaking Hearing_SBHC-RAC_11.2025, 333-028 SBHC SNFI_2025-RAC-v1, 333-028 SBHC-Rule-Revsions_TrackChanges_RAC_v1-10.23.2025, SBHC-
 - CertificationStandards_v5_TrackChanges_RAC_v1_10.23.2025).
- SPO reviewed process thus far. Beginning in 2022 conducted literature review, surveyed SBHCs, engaged youth & other partners, drafted text, convened Standards for Certification workgroup in 2023-2024, presented the proposed changes to SBHCs in Fall 2024, conducted additional





engagement & SBHC surveys, presented to CLHO 3 times in 2023-2024, and finalized the Standards. Met with DOJ for 4 months regarding language that was proposed, finished in September 2025. Shared where the RAC falls within the OAR rulemaking process.

Review Proposed Notice of Rulemaking

Supporting Document: 333-028 Notice of Proposed Rulemaking Hearing_SBHC-RAC 11.2025

- SPO went through each section of the Notice of Proposed Rulemaking Hearing document and document link was shared with RAC members.
 Members were asked to provide questions and comments.
- No RAC feedback.

Review Statement of Need and Fiscal Impact

Supporting Document: 333-028 SBHC SNFI_2025-RAC-v1

- SPO went through each section of the Statement of Need and Fiscal Impact document and distributed document link to RAC members. Members were asked to provide questions or comments on each section.
- Need for the Rules section: No RAC feedback.
- Documents Relied Upon section: No RAC feedback.
- Racial Equity Impact Statement section:
 - Group discussed concerns about use of "racial equity" language, given federal guidance to remove "equity" language for entities that receive federal funding. SPO responded that the Racial Equity Impact Statement is a requirement of the state rulemaking process and will be reviewed at the state level. The data and information shared in the Racial Equity Impact Statement are similar to what the SPO has shared in other settings (2025 SBHC Status Update, public presentations, etc.) about SBHC clients and utilization.
- Fiscal and Economic Impact section: No RAC feedback
- Statement of Cost of Compliance section:
 - Karen stated that the number of sites not meeting the contraceptive dispensing requirement is now lower than 13 of 89 SBHCs.
 - Melanie noted the number reflects the number of SBHCs that would need to make changes to comply and doesn't reflect those that have





already updated their services. Tracking of SBHC preparations for the rule and Standards changes is ongoing.

Review SBHC Program Oregon Administrative Rules (OARs)

Document: 333-028 SBHC-Rule-Revsions TrackChanges RAC v1-10.23.2025

- Recent engagement efforts to modernize the rule text and SBHC Standards for Certification have resulted in proposed changes to the SBHC Program OARs. SPO made a few additional changes after consulting with DOJ. The changes are intended to clarify process and remove any duplicative language.

 will be updated.

- Group discussed how Standards may be changed or enforced differently, given changing federal guidance. Questions if state will develop more explicit guidance on some topics covered in Standards for Certification, Version 5. SPO responded that Standards requirements are aligned with local, state, and federal law. The new requirements have been shared with OHA leadership. They have not recommended any changes to the Standards at this time.

Next Steps

- Review any proposed rule changes and make any final revisions.
- The SPO will submit the rules forms to the Rules Coordinator who will file notice of proposed rulemaking with Secretary of State.
- SPO will update the website with any changes.
- In the Spring after the legislative session, the SPO will hold a public hearing with a public comment period.
- SPO will respond to the comments and make any finalized changes.
- SPO will file the permanent rules with the Secretary of State office.
- The new rules will go into effect July 1, 2026.
- The SPO will share the RAC minutes, copies of the revised text and information about the public comment period with the RAC members.
