Changes to staff detail / roles / credentials section of Operational Profile (OP) database

Certification Roles These are the roles that are included in the certification standards as required roles or roles that can count towards minimum hour requirements. Qualified Mental Health Professional (QMHP) isn't a new role but it now has an asterisk next to it to indicate a QMHP does need to meet OAR 309-019-0125 Staff Qualifications and Competencies but does not need to registered or credentialed through Mental Health & Addictions Certification Board of Oregon (MHACBO)

Other Roles

To better understanding staffing roles in SBHCs the State Program Office has updated this list. Some of roles that were previously listed have been removed or replaced with similar roles with new titles. We know the titles used by agencies can vary and it's okay if the title doesn't match up exactly with the role listed here, but hopefully this expanded list will offer roles that more closely align with some of the positions currently staffed in SBHCs.

Credentials – Mental / Behavioral Health

Previously, the credentials listed in this section included various MH / BH licensures and Certified Drug and Alcohol Counselor (CADC) types. To gather more accurate information on SBHC staffing, the credentials have been expanded to include clinicians working towards licensure (Associates) as well as Psychiatric Mental Health Nurse Practitioner (PMHNP) and Qualified Mental Health Associate (QMHA).

Credentials should be verifiable either through MHACBO or a licensing board specific registry. Again, to ensure accurate OP entries please consult with the mental health agency when completing the OP.

Credentials – Traditional Health Worker

Traditional Health Worker (THW) used to be included in "Other Roles" section. That section now includes specific types of THWs – Community Health Worker (CHW), Peer Support Specialist (PSS) and Peer Wellness Specialist (PWS). In order to check the THW credential box we ask that the staff person is <u>certified with OHA</u> and there is a corresponding role checked in the "Other Roles" section. The THW credentials is listed separate from other credentials because THWs may be working in positions that could fit under either physical or mental / behavioral health as it is separated in the OP. Here is a screenshot of the OP Staff record illustrating the changes described above:
