### What if the board/council enters into executive session?

Prior to entering executive session, the board/council chairperson will announce the nature of and the authority for holding an executive session. Board members, designated participants such as staff, and representatives of the news media shall be allowed to attend the executive session. All other audience members are not allowed to attend the executive session. If scheduled on the agenda, any executive sessions would be held according to Oregon Revised Statute 192.660. No final actions or final decisions will be made in executive session. The board/council will return to open session before taking any final action or making any final decisions.
