CERTIFICATE FEES FOR CLIA LABORATORIES

CLIA fees for Waived, PPMP, and Non-accredited Moderate & High Complexity laboratories.

The following is the fee schedule for all non-accredited clinical laboratories in Oregon. Waived and PPMP laboratories are assessed only one fee for issuance of a ‘Certificate of Waiver’ or ‘Certificate of Provider Performed Microscopy Procedures (PPMP)’. Non-accredited clinical labs performing moderate and/or high complexity tests are assessed three fees. The first fee is for issuance of a ‘registration certificate’. The second assessment is the compliance or survey fee which is based on the number of specialties performed and annual test volume. The third fee or Certificate fee, follows completion of the CLIA survey, and receipt of that fee releases the new Certificate of Compliance.

FEES FOR CLIA CERTIFICATE OF ACCREDITATION

This page for laboratories accredited by AABB, AOA, ASHI, CAP, COLA, JCAHO.

The following is the fee schedule for all privately accredited clinical laboratories in Oregon. Waived and PPMP laboratories are assessed only one fee for issuance of a ‘Certificate of Waiver’ or ‘Certificate of PPMP’. Accredited labs performing moderate and high complexity tests are assessed two fees. The first fee is for issuance of a ‘Certificate of Accreditation’. The second fee is each laboratory’s share of the Centers for Medicare and Medicaid Services validation costs to determine their accreditation organization meets or exceeds CLIA requirements. Both fees must be paid in order to receive a ‘Certificate of Accreditation’.
