# Trusted Messengers: OHA Talking Points: Pfizer now approved for ages 12-17-years NEW

## PREP Act Expansion NEW

On March 22, 2021, the Oregon Health Authority authorized the Prep Act Expansion of the Vaccinator workforce in Oregon. OHA's Authorization expands health professions who may administer vaccine in Oregon, after meeting all requirements listed therein. For more detail, read OHA's PREP Act Authorization Explainer and Frequently Asked Questions.

SERV-OR has not established a tracking system for these requirements. At this time, and until otherwise informed, all volunteers who meet the Authorization's requirements, are responsible for documenting their completed requirements and providing documentation to SERV-OR to be deployed as a vaccinator.

### Stories of Service NEW

From Allyson

Allyson retired from EMS to become a union organizer. She let her EMT license expire, figuring that there wouldn't be much need for her license as a volunteer. She has been a member of SERV-OR for years and has volunteered at a few events, like the Solar Eclipse in 2017. As soon as the gravity of the pandemic began to set in in February of 2020, she began to feel the pull of wanting to help. Consulting her dad, an EMS physician, she was able to get all her requirements up to date, and by April she was recertified. Being a union organizer meant paid deployments were pretty much a non-starter. She then reactivated herself in SERV-OR. Once the vaccine was approved, she completed her training and since then she has been volunteering to give vaccines every weekend through the Multnomah County MRC and OHSU clinics.

Allyson writes, "I am so happy to be able to make a small contribution to our effort against the pandemic and it's really amazing to see our entire community contribute, especially the healthcare workers who already work tirelessly day in and day out fighting this disease."


