Volunteer Update NEW

We are taking some time to share what is happening with SERV-OR volunteers overall during this emergency response.

We want to extend a big "Thank You!" to all our new and existing volunteers! We are truly grateful to each and every one of you! We have gotten emails from folks, wondering why we've had so few actual activations to date. The answer to that is good news! Oregon has one of the lowest rates of COVID-19 cases per 100,000 people in the nation. With this level of illness, our hospitals and health systems have so far been able to cope with the disease burden without needing much, in terms of extra help.

Although we as a state have been able to respond well so far, we know how important it is to have a strong and willing cadre of volunteers able to support our frontline efforts. Our volunteers can be critical









to a response if we are subject to a second wave of disease and all of these efforts to "flatten the curve" are not as successful. So, we continue to recruit new volunteers, encourage everyone to complete the required trainings and update profiles as often as necessary.

Contact Tracing Updated

In Governor Kate Brown's latest press conference, she laid out plans to increase contact tracing as a necessary next step for Oregon to re-open. If you are interested in assisting with contact tracing and are a member of a local MRC, please contact your MRC Unit Coordinator for more information on the county or Tribe's contact tracing plans for engaging volunteers in the effort. If your county does not have one, you are able to join a nearby unit. If the local health department has decided to utilize volunteers for contact tracing, they will be in touch to coordinate vetting, training and onboarding.

At this time, members of the State Managed Volunteer Pool have not been requested for this effort. Thank you for your understanding, as we await more information on how volunteers can be best utilized. If you have interest in or experience with contact tracing, and haven't already filled out our COVID-19 Deployment Interest Survey, please do so and be sure to check "Yes" on Question 14. Please do not complete the form again if you have already done so once.

Cannon Beach	MRC not activated as of last report received 5/1/20.
Clackamas County	Current Status: Active. Current Activities: Telephone contact tracing interviews. Previous activities: Staffing public inquiry call center.
Columbia County	Current Status: Not active. Recent Activity: MRC volunteers participated in contact tracing training.
Coos County	Current Status: Active. Activities: Screening front doors; RSS for State stockpile items; Admin and volunteer scheduling; Social media monitoring; Response planning and meetings; Administrative support.









Curry County	No activities reported.
Deschutes County	No activities reported.
Eastern Oregon Region 9	Current Status: Active. Activities: 1 day of activity per week to support Baker County Health Department. Activities included providing immunizations, COVID-19 screening and information, sexual health information, public health support, RN support.
Lincoln County	MRC was formally established as of May 12, 2020. Current Status: Not active.
Linn County	Current Status: Active. Current Activity: COVID-19 specimen collection. Previous Activities: 26 volunteers deployed for 1 day to check patients in with registration paperwork; fill out lab paperwork; facilitate COVID-19 NP swab; and sanitize supplies. Staffing call center, disease investigation; supply distribution; and partnered with Environmental Health Staff to do educational visits with partners.
Marion County	Current Status: On Standby since 4/9/20. Previous Activities: Setting up the Oregon Medical Shelter (OMS); Creating database for contacts to support mass care; and contacted cities to assess mass care needs.
Multnomah County	Current Status: Active. Current activities: Case investigation and contract tracing. Previous Activities: OHSU student volunteers making calls for communicable disease and staffed warming station.
Nehalem Bay	Current Status: Not Active as of last report received 4/1/20. Previous Activities: Conducting phone interviews; and coordinating volunteers.
State Management Volunteer Pool (SMVP)	Current Status: Active. Current Activities: Douglas County Public Health Network Call Center; support volunteer management operations and coordination; and supporting crisis care guidance work. Previous Activities: Set up and staffed OMS; logistical warehousing; Grand Princess SAT; specimen collection strike team; LTCF outreach calls; support implementation and optimization of crisis standards of care.
Wasco County	MRC not activated as of last report received 5/14/20.
Washington County	Current Status: Active. Activities: Volunteer Coordination; staffing call center; administrative support; PPE donation site; outreach-food bank errands; and COVID-19 mask production.
Yamhill County	Current Status: On Standby since 4/6/20.







Reopening Oregon NEW

Oregon is moving forward with reopening the state. Different rules apply depending on what county you live in. As of today's date, all but one county have applied to enter Phase 1 of reopening. Multnomah county has not yet applied, and Washington County's application is currently under review.  - o **Exercise regularly, get plenty of sleep.**
 - Avoid alcohol and drugs.
- Make time to unwind. Try to do some other activities you enjoy.
- Connect with others. Talk with people you trust about your concerns and how you are feeling.
