- 1. OHA seeking advanced Spanish/Spanish bilingual Contact Tracers & Case Investigators Requirements:
 - a. Complete remote online trainings. Trained SERV-OR volunteers will remain on standby and may be asked to support case investigation efforts throughout the state.
 - b. Remote communications technology (computer, internet, phone)

- **2. Josephine County is seeking volunteers for Contact Tracing** (Josephine County residents only) Requirements:
 - a. Time commitment of approximately 10-20 hours per week during larger outbreaks; 0 hours when no outbreaks occur; other weeks may require daily check-in meetings (8-12 hours per week) and weekly refresher trainings.
 - b. Remote communications technology (computer, internet, phone)
 - c. <u>Preferred but not required</u>: Previous contact tracing experience; access to or familiarity with emergency health records (EHRs) and/or database entry.


MRC Unit	Summary of Activities
State Management Volunteer Pool (SMVP)	Current Status: Active. Current Activities: OHA Incident Management Team, Douglas County Public Health Specimen Collection and the COVID Response and Recovery Unit (CRRU) Testing Unit logistics support.
Coos County	Current Status: Active. Activities: Screening front doors; RSS for State stockpile items; Admin and volunteer scheduling; Social media monitoring; Response planning and meetings; Administrative support.
Eastern Oregon Region 9	Current Status: Active. Activities: 1 day of activity per week to support Baker County Health Department. Activities included providing immunizations, COVID-19 screening and information, sexual health information, public health support, RN support.
Linn County	Current Status: Active. Current Activity: COVID-19 specimen collection.
Multnomah County	Current Status: Active. Current activities: Case investigation, contract tracing, and making phone calls.
Washington County	Current Status: Active. Current activities: Delivering meals.

Long Term Care Calls Mission NEW

Demobilized: Volunteers spent nearly 100 hours conducting outreach calls to long-term care facilities to support OHA's effort to obtain information on testing needs and capacity. Volunteers we needed to ensure facilities received and completed them. Volunteers had a significant impact on efforts to meet the testing needs of long-term care facilities in Oregon.

This deployment increased the survey completion rate from less than 4% to over 54%!

FEMA NEW

FEMA is currently hiring for five CPCB Managers to support disaster field work. These are full time positions, with benefits, requiring significant disaster travel of up to 300 days a year (Incident Management Cadre of On Call Employees – IM CORE). Lines for Life Oregon Health Behavioral Access Job Opportunities:

<u>Behavioral Health Database Services Coordinator</u> – This is a temporary full-time position that will develop a Behavioral Health Provider directory as part of Lines for Life's Oregon Behavioral Health Access project. The purpose of the directory is to provide one place where anyone can go to find any behavioral health service in Oregon with the most up-to-date availability of every service. The position will last until December 2020.

<u>Recruiter for Behavioral Health Providers</u> – This position will recruit and set up contracts with clinicians who represent various communities and languages to answer calls on a behavioral health support line in order to help connect callers with culturally specific behavioral health services. This is a temporary position expected to last through December 2020.

<u>Culturally Specific Crisis Intervention Specialist</u> – Lines for Life is launching a new culturally specific emotional distress line that will serve people of color who are feeling stress and emotional distress from racism, oppression and microaggression and is seeking to hire 1 more full-time Crisis Intervention Specialist to answer calls on this line.

<u>Helping the Helpers Group Facilitator</u> –Lines for Life is looking to hire 2 people to facilitate emotional support groups for front line workers and behavioral health clinicians during the COVID-10 pandemic. These are temporary positions expected to last through December 2020

Contractors sought to support COVID-19 testing at long-term care facilities

The Oregon Department of Human Services (DHS) and Oregon Health Authority (OHA) have posted a request from organizations interested in partnering with the state to test all staff and residents of long-term care facilities.

Applications are reviewed and contracts awarded on a rolling basis. Vendors should apply sooner rather than later. The RFA seeks applicants that can perform specimen collection and diagnostic testing for COVID-19 infection in Oregon as part of the state's effort to test all long-term care facility staff and offer testing to all residents by September 30, 2020.
