Changing Role of Paramedics under COVID-19 NEW

From private companies to public agencies, paramedics are working under an expanded scope of practice as Community Paramedics and Mobile Integrated Health partners alongside other patient care team members to bring the best care to the patient. Paramedics are no longer working just on an ambulance or just with a fire department. The time of "load and go" is ending as patient specific care becomes the standard of practice.

EMS has been able to contribute in patient care during COVID-19 with new services ranging from community testing and exposure tracking to quarantine site placement. Health care has been rapidly changing during this pandemic and may never be the same again. Telemedicine, home health, the return of health care provider home visits have revitalized a system under siege. And this time, paramedics and EMT's have had a key role to play. Paramedic is no longer the peak of a career and training. As tomorrow brings more challenges, health care will continue to face these challenges on many fronts with the goals of preparation, patient care, and prevention. EMS will play a vital role in this transition.

The Coos County MRC focus in January and February was on public health incident command and emergency operations through the efforts of our leaders, Phillip Nel and Michael Burton. In February the MRC, along with some of our CERT members, set up a casualty collection point – the weather, although cold, supported us in setting up the tent and using tapes to mark out how patients would "flow" through the collection point.

In August we worked together to set up a large tent for COVID-19 screening for our fisher families. In addition, we have had a number of WASH (Water and Sanitation Hygiene) trainings for MRC, CERT and community members. We also had a session on ham radio operations put on by one of our members. These sessions help us reflect on how important communication and those who operate ham radios will be in an emergency.

Our MRC volunteers have also made a splash in supporting our public health department through volunteering to help screen members of the public in need of public health services, create hygiene









packets with hand sanitizer, masks and temperature strips to distribute to locals who are homeless. We have created over 4,000 hygiene packets! In addition, our MRC volunteers helped manage the Coos County PPE stockpile for a few months to log inventory. Several of our MRC members are training as contact tracers, to add to the health departments staff for this critical work during the COVID-19 response. The Coos County MRC is a valuable asset to our community now and in times of emergency need!
