

COVID-19 Vaccine Administration Training Checklist and Attestation

MODERNA

Prior to Administration

Any staff assigned to administer the COVID-19 vaccine must complete required trainings for administration of each of the vaccines that have received emergency use authorization by the FDA.

- **Not on the list?**
 - **Option 1:** If your professional scope does not allow vaccine administration, you may be permitted to administer as an [unlicensed medical assistant](#) under the delegation and supervision of a license type with authority to delegate (see vaccinator categories). Submitting this attestation is a requirement to receive delegation as an “unlicensed medical assistant.” **Not all sites are delegating.**

ALERT IIS Standard User Training (RECOMMENDED AND HIGHLY IN NEED)

The statewide immunization registry providing consolidated immunization histories for use by vaccination providers and data that guides public health action to reduce vaccine-preventable disease. **When mobilized, you will be assigned access under a provider entity (health department, hospital, etc.) If you participate in multiple deployments under different entities, you will need access reassigned for each deployment.**
