There are many challenges to entering Oregon's emerging psilocybin sector. You'll also hear about payroll taxes and special tax challenges that apply to businesses associated a Schedule I substance, including Section 280E of the Internal Revenue Code, which prohibits businesses from deducting ordinary business expenses. Starting a psilocybin business comes with some challenges, but getting equipped with information and resources can help make the process much smoother.

Some of the rules related to psilocybin products and testing were adopted in May and outline three different manufacturer endorsements: "fungi cultivation", "psilocybin extraction", and "edible psilocybin production". If you are planning to cultivate psilocybin, prepare psilocybin products, or offer psilocybin testing services, join us to learn from the Oregon Environmental Laboratory Accreditation Program (ORELAP) on how psilocybin products will be tested and how testing labs will be accredited. You will also learn from the Oregon Department of Agriculture and the Food Safety Program at the Oregon Health Authority regarding where the intersection of their programs may impact psilocybin products and manufacturing.
