RE: Notice of proposed permanent rulemaking – OAR 333-333-4300,

"Oregon Psilocybin Services - Licensed Premises Location

Requirements"

The Oregon Health Authority, Public Health Division, Oregon Psilocybin Services (OPS), is proposing to permanently amend OAR 333-333-4300 to remove an unnecessary reference and clarify requirements for temporary events at licensed psilocybin service centers.

Proposed rule amendments will ensure that licensed psilocybin service centers are not able to host temporary events at their premises after 11:59 PM. Events that extend beyond 11:59 PM are not consistent with the safe and orderly operation of psilocybin service centers; and they are more likely to involve intoxicated individuals who have consumed alcohol at neighboring businesses. These rule changes were filed as temporary changes effective August 29, 2025 through February 24, 2026 (Temporary Administrative Order PH 15-2025) and this proposed permanent rulemaking seeks to make those changes permanent.

The proposed rule amendments will also allow for single written notice of temporary events at a service center occurring within a 180-day period.

The proposed rule amendments clarify requirements for manufacturers by removing an unnecessary reference to Oregon Department of Agriculture requirements.

You are invited to review and comment on the proposed rules. If you wish to present oral comments on the proposed rules, a virtual public hearing is scheduled.
