Background

Beginning January 1, 2026, facilitator licensees must report at least four hours of continuing education to be eligible for license renewal. These hours must have been completed during the annual license period preceding their renewal application. Facilitators who provide continuing education may report those hours to meet reporting requirements. To clarify, facilitators may count the time they spend providing qualified training sessions as part of their own required training hours, as long as those sessions meet the reporting requirements.

As part of renewal application requirements, licensed facilitators must provide documentation of the education received. For more details about this requirement, please refer to OAR 333-3300.
