Dear Licensed Psilocybin Service Centers,

We are writing to inform you of expected changes to 303 data reporting requirements that will become effective January 1, 2026.

303 Client Data

[HB 2387](#), passed by the 2025 Oregon Legislature, amends [475A.372](#) to require the collection of 'veteran status' of clients, which will be added to the 303 Client Data Form.

Also, there will be new categories added to the racial and ethnic identity questions to reflect the REALD and SOGI Demographic Data Collection Standards ([OAR 950-030-000](#)), developed through a rulemaking process led by the [OHA Equity and Inclusion Division](#).

In response to helpful licensee feedback, the form will also include "Don't know" and "Don't want to answer" as response options to both preferred language questions. Instructions to "Circle your primary racial or ethnic identity" have been updated to make it easier for the form to be used electronically. The form may also have updated "Opt-Out" language to clarify that the client opt-out option is for clients who do not want their responses included in the total numbers (aggregate data) submitted to OPS.

OPS follows data standards set by the Oregon Health Authority, including deidentification standards, before publishing aggregate data on the [OPS Data Dashboard](#).

Service Center Data

Beginning in 2026, service centers may be required to report the Number of Clients who selected the “Client Opt-Out Option” to improve data quality.

What to Expect

We are sending this letter to provide a heads-up on what you can expect for 2026. We are currently in the public comment period for [OPS 2025 Rulemaking](#). New and updated administrative rules have not yet been finalized.

By early November, we plan to send an updated 303 Client Data Form which must be used beginning January 1, 2026. In addition, we will send an updated 303 Data Reporting Guide for Service Centers that reflects these expected changes for 2026.

As a reminder, service centers must submit the data required by ORS 475A and OAR 333-333. The specific data required may continue to change over time as new legislation and administrative rules are adopted. We understand that changes can create administrative burden. We want to thank you for your continued adaptation and feedback. To support your preparation for meeting new data collection and reporting requirements that will become effective January 1, 2026, we have included an appendix that outlines expected changes to the 303 client data requirements.




