Welcome and Call to order (André Ourso)

• André Ourso started introductions. All Psilocybin Advisory Board Members introduced themselves with a brief overview of their backgrounds and interest in psilocybin research.

Opening Remarks: (24:23 on audio)

Jeff Rhoades, Senior Policy Advisor to Governor Brown, shared some of the Governor's concerns around developing OHA's psilocybin program, ensuring an equitable approach, and prescribing an equity and access subcommittee.

Purpose of Psilocybin Board and Overview of Measure 109 (33:24 on audio)
Sam Chapman, Campaign Manager for Measure 109, and Executive Director of the
Healing Advocacy Fund gave a summary of the measure, and the next steps.
Tom Eckert spoke about the inspiration behind Measure 109 and shared thoughts on
defining an Oregon model of psychedelic care based on an underlying set of principles:
access to services, rationality - embracing science, safety and ethics, recognizing risk,
and ultimately supporting a healthy community-based marketplace.

Update and Organization of the Psilocybin Services Program (01:02:00 on audio)

André Ourso talked about hiring staff for the program. 3 FTE's anticipated.

Initial Board Tasks and Assignments (01:03:36 on audio)

Andre shared a draft bylaws template with an overview of the basic articles. There was a discussion about using a co-chair vs. chair/vice-chair structure. The conversation was ultimately tabled for later discussion.
