RE: Notice of proposed permanent rulemaking – OAR chapter 333, division 333,

"Oregon Psilocybin Services Rules"

The Oregon Health Authority, Oregon Psilocybin Services (OPS) section is proposing to adopt administrative rules in chapter 333, division 333. The proposed rules implement ORS chapter 475A, the Oregon Psilocybin Services Act ("the Act"). The Act creates a first of its kind regulatory framework for licensed production of psilocybin products and sale of psilocybin products and services to clients. The rules address all aspects of this framework and support the Act's goals of promoting access and equity while protecting health and safety. The rules are necessary to implement the Act which requires that they must be adopted by January 1, 2023. The rules address a variety of subject matter including requirements for licensure including storage and security, standards for psilocybin products, packaging and labeling requirements, safety standards and guidelines for provision of psilocybin services, client rights and informed consent processes, facilitator duties, compliance, product tracking and transportation. You are being invited to review and comment on the proposed rules. If you wish to present oral comments on the proposed rules, two virtual public hearings are scheduled. Spanish interpretation, American Sign Language interpretation, and CART captioning services will be provided at the hearings.
