## Oregon Psilocybin Services

To Licensed Manufacturers,

On October 24, 2025, new and updated administrative rules were adopted and will go into effect on January 1, 2026. This letter describes some of the important changes related to manufacturers. For a complete description of new and updated rules, please read the 2025 OPS Rules with Tracked Changes.

## **Psilocin on Psilocybin Product Labels**

OPS made important changes to label rules to implement legislation and provide greater clarity to clients and facilitators about product potency. The Oregon Legislature amended ORS 475A to require psilocin content to be listed on psilocybin product labels, and OAR 333-333-2400 has been adjusted to reflect this requirement. OPS made additional changes to require product labels to display any other values regarding available, potential or equivalent psilocin or psilocybin that are identified by the laboratory who performed potency testing. Detailed information on compliance with revised label rules has been included in the attached Product Label and Potency Letter. We share this information with manufacturers to ensure that all psilocybin products transferred to service centers on or after January 1, 2026, are compliant with the amended rules.

# **SB 907: Property Owner Consent**

SB 907, recently passed by the Oregon Legislature, requires licensed manufacturers and applicants for manufacturer licenses to submit a notarized consent form that shows the owner of the real property approves of its use. The bill also requires OPS to independently verify property ownership. Rules

have been updated to reflect these requirements, and OPS will publish a revised Property Owner Consent for Manufacturing Psilocybin later this year. Existing manufacturer licensees will need to submit a revised form with their license renewal application and property owners may consent to one or more license terms.

#### **UIN Numbers**

The definition of "Unique Identification Number" has been amended to include references to the specific stages in the product life cycle. Please note that although the abbreviations "UIN" and "UID" are sometimes used interchangeably, "UIN" is the accurate term. Manufacturers should use the term "UIN" rather than "UID."

## **Potency Information Document**

OPS amended OAR 333-333-5000 to require that the <u>Psilocybin Product</u> <u>Potency Information Document</u> is discussed with clients during a preparation session. This document supports client decisions on selecting a product type and dose that aligns with their intentions for the administration session. Previously licensees were encouraged to provide this document to clients, but due to ongoing concerns about product potency safety the document is now required to be provided to clients.

## **Other Changes**

OPS amended OAR 333-333-2030 to clarify that a manufacturer may only transfer psilocybin products if they hold the appropriate endorsement for that product type. Existing text already required an endorsement for production and sale of psilocybin products. The amendment is not a prohibition, but rather a requirement that manufacturers hold an endorsement for the products they transfer.

OPS amended rules to enable efficient collection of unpaid civil penalties for administrative violations. Under the amended rules, failure to pay a civil

penalty imposed by final order is a basis to deny applications for license and worker permit renewal.

OAR 333-333-4200 has been amended to require prior approval when adding an individual or legal entity who qualifies as an applicant, and when changing the licensee's operational name.

OAR 333-333-4250 has been amended to remove reinspection periods and treat non-compliance discovered during a license renewal inspection identically to compliance issues discovered in other contexts.
