The purpose of this letter is to kindly request modification for our Dental Pilot Project #300, "Dental Therapist Project: Dental Hygiene Model." This modification includes the requested change to add new practice sites. Specifically, we wish to include an additional 13 pilot sites managed by Willamette Dental Group.

### Addition of new practice sites
