# Notes from November meeting to review and approve:

- Gratitude to Cate Wilcox for reading the grounding statement.
- Minutes from August meeting approved.
- No update from the subgroup supporting the State Medical Examiner's Office. Jill Baker agreed to determine next steps for February meeting.
- Reviewed resource and system improvement identifying complete items and priorities for next steps.
- Agreed to annual review of the resource and system improvement plan as some items are ongoing and will not be 'complete'.
- Member changes Deb continues to work with ODE to identify a new member. Office of Child Care, Field Operations Director, Miriam Cecilia engaged in onboarding and attended her first meeting as a state team member.
- Discussed creating a mock review to have with any written guidance on how to conduct child death review.
- Oregon Child Death Review and Prevention Website is implemented.





- The state team was approved for a Microsoft Teams pilot and members have now been invited to join. If you need assistance, contact Deb Carnaghi.
- Presentation by guest, Dr. Ben Hoffman on drowning data. Request for Dr. Hoffman to share
  with the state team any legislative concept developed to address drowning deaths. Discussed
  equity issues surrounding drowning deaths, age of those who are drowning, and drowning that
  are not related to boating.
- Suicide data presentation was provided by Taylor Chambers.
- Injury prevention data presentation was provided by Heather Morrow-Almeida.
- County Team Support –A meeting was scheduled by Deb Carnaghi for those members
  assigned to a county team to discuss what is/is not working and potentially explore a different
  path towards supporting counties.
- Safe Sleep Coalition hosted a listening session for county teams in September. The coalition and state team will make efforts to collaborate going forward.
