Notes from November meeting:

- Gratitude to Jill for reading the grounding statement, Robin for overseeing the chat and Emily for tracking on time.
- Minutes from August meeting approved.
- Announced Kat's job transition and subsequent departure from the team. Welcomed Cassy to the team as a new member and representative from Oregon Child Abuse Solutions.
- Others not yet on Teams should reach out to request support if they too are having technical issues.
- Discussed and received support for identifying and using existing bodies for prevention implementation.
- The National Center for Fatality Review and Prevention agreed to facilitate the Equity training opportunity to Oregon county team leads and coordinators. Asked for a volunteer to move this work forward.

- Discussed prevention recommendations would be reviewed next meeting and cover recommendations from August to February.
- Membership workgroup met and agreed to share the draft membership spreadsheet with the entire state team during the next meeting. Follow up with Cate Wilcox about tools.
- Peer support workgroup led by Kathleen. Reviewed templates for agenda and communication.
- All county teams responded to request for role specific member contact information.
- Extensive discussion about fentanyl.
- Laura taking lead on effort to draft guidance/health alert for infant/child/youth poisoning prevention (treatment options, follow up, how to identify). Discussion about DMPs and pediatrician's distributing. There could be multiple guidance docs geared to different audiences. Could proceed with a bundle of three 1-2 pagers as a toolkit.
- Deschutes county team members Gil Levy and Sgt Timothy Guest presented the circumstances of a child death in their county for the purposes of discussing prevention responses that could occur locally, across counties, or statewide.
- ODOT representatives joined the meeting to contribute to prevention discussion regarding e-bikes.
- Debriefed the overdose prevention information and listening session that was held for county teams. Savannah Santarpio with OHA attended state team to participate in this discussion as she was instrumental in the listening session. Session had 40 participants and was determined successful. Discussed how to continue the dialogue with the group who attended.
- Volunteers for next time include Chuck reading the grounding statement, Amber overseeing the chat, and Cassy tracking time - thank you in advance for stepping up.
