Notes from May meeting:

Gratitude to Robin Reimer for reading the grounding statement

- ODHS, OHA, and DOJ partnering on different efforts aimed at funding the work of the state team
- Sudden Unexplained Infant Death Investigation (SUIDI) subgroup met. Participants include Dr. Carissa Cousins, Jennifer Snippen, Kris Karcher, Robin Reimer, and Deb Carnaghi. Exploring what content and approach to use to train law enforcement, district attorneys, medical professionals, and Child Welfare statewide. Also exploring resources to support SUIDI such as C-POD app used in Indiana.
- Subgroup to support the Oregon State Medical Examiners has begun to seek an understanding of the needs of the State Medical Examiner Office. Participants include Jill Baker, Amanda Couch, and Heather Morrow-Almeida. Dr. Hurst anticipates having more time in the fall to engage in these efforts.
- All feedback from county teams on the draft Resource and System Improvement Plan was positive and plan is now finalized with projected completion dates for each item. Final plan to be distributed to county teams (see action items below).





- Discussed reviewing prevention recommendations from the last quarter at next meeting to prioritize charter review and establishing the system within which we can act more substantively on recommendations.
- Presentation on child maltreatment fatality data from FFY 2021
- Discussion about having child maltreatment fatality data from prior years to support trend identification.
 Agreement to develop spreadsheet with prior years data to eventually have available on website through password protected portal for state team members.
- Suggestion by Robin Reimer to contract for needs assessment for the State Medical Examiner Office.
 Agreement to reach out to the National Center and use their list serve to inquire with other states about how they have successfully supported their state's medical examiner's office. Identify paths that have been successful.
- Commitment to improve how the chat is integrated into the flow of the meeting.
- Charter reviewed and feedback provided. Charter subgroup to incorporate feedback. Goal to have charter complete prior to August meeting via email review by state team. Feedback captured on shared document during meeting and not listed out here.
- Next meeting agenda to focus on prevention recommendations, suicide and injury prevention data and furthering work that is underway.
