Approved Notes from May meeting:

- Gratitude to Chuck Mickley for reading the grounding statement, Emily for overseeing the chat and Cate for tracking on time.
- Minutes from February meeting approved.
- Dr. Ben Hoffman provided on update on water safety legislation. The legislation did not move forward in the 2023 session but may be pursued in the next short or full session. Offered support from state team.
- Welcomed Oregon Child Abuse Solutions' Kat Hendrix as a new member of the state team
 - With gratitude announced the departure of Amber Kroeker with Legacy Health Systems, Injury Prevention as a member of the state team
- Many folx have signed their re-commitment letter for the state team, but there are still others that need to sign or reach out to a state team co-chair





- Ensured everyone received information about the counties offering to host state team members wanting to observe. Emily and Kathleen graciously offered Multnomah and Washington County team meetings respectively.
- Several members have reached out to Deb Carnaghi with issues getting into Teams and those
 issues are being addressed. Others not yet on Teams should reach out to request support if
 they too are having technical issues.
- An update from Dr. Sean Hurst related to the State Medical Examiner's Office was provided and the email from Major Alex Gardner detailing some of the challenges faced was forwarded to members.
- Discussed equity training opportunity in the context of death review. The National Center has
 agreed to facilitate the training activity. This is not a one and done and rather continues the
 important dialogue about equity. It is acknowledged that many state team members have
 participated in anti-racist and equity trainings and plans to follow up to better understand gaps
 and needs on the team for continued education, including with this specific context.
