Notes from May 2025 meeting:

- Gratitude to Lani for reading the grounding statement and Taylor managing the chat.
- Notes from February meeting reviewed and approved.
- Discussed membership changes. Amanda Nadell, Multnomah County Chief Deputy District
 Attorney, is a new regular member taking over from Chuck Mickley. Alanna Russell will be back
 up for Jennifer Johnson at Oregon Department of Education. Both Amanda and Alanna have
 been onboarded.
- Shanda updated the group on Retrospective Suicide Analysis (RSA), informing members that
 the first RSA is complete. Recommendations were shared and Shanda agreed to bring more
 information after enough RSAs have been complete and more findings are identified.
- Amanda shared contact with ODAA Director occurred and the team has access to newsletter or generally forms of communication for reaching DAs.
- The Ronald W. Naito MD Foundation just granted \$60,000 over the next two years to support mental health training for CAC clinicians.
- Grant to distribute wellness kits to schools that addresses youth mental health. The kits come
 in little backpacks and have things like stress balls, journals, coloring books, mental health
 resources, lotion, etc. Currently distributed through a few partners in PPS. These are age
 based (K-3, 4-7, 8-12grade). This started as a response to the pandemic but continued due to
 success.
- OCDC provides cribs for families that are enrolled and provides safe sleep training for parents in both English and Spanish and can provide to the community as well.
- Reviewed prevention recommendations from three child fatality cases and identified resources for follow-up with county coordinator. Robust discussion regarding resources for children who are suicidal and the existing gaps as well as safe sleep resource discussion.





- Brainstormed methods for improving medical provider access to medical records for death review. Action items reflect next steps. Natalya re-briefed the group on the perspective gathered at the medical provider peer group.
- Updates:
 - Randall Children's Hospital has received a grant from the ODOT Transportation Safety
 Office for a child car seat project, which will focus on booster aged children, reach out to
 Amber with referrals.
 - o Randall FT health educator position posting.
 - o Emily invited members to participate in upcoming Multnomah County reviews
- Next quarterly meeting will be August 28, 2025. Emily volunteered to read the grounding statement and Katrina volunteered to monitor the chat.
