Notes from August meeting:

- Gratitude to Emily for reading the grounding statement, Heather for overseeing the chat and Kat for tracking on time.
- Minutes from May meeting approved.
- Many folx have signed their re-commitment letter for the state team, but there are still others that need to sign or reach out to a state team co-chair.
- Others not yet on Teams should reach out to request support if they too are having technical issues.
- Discussion about how SUID is described on death certificates.
- Dr. Sean Hurst provided an update on the State Medical Examiner's Office. The updates to ORS 146 did not pass. There are service changes to the counties that are implemented. The state no longer provides county ME services. Access to autopsies has not changed. There is a workgroup developing an improvement plan.





- The equity training opportunity in the context of death review was facilitated by the National Center for Fatality Review and Prevention. Presenters agreed to forward the slides.
- Team agreed the training opportunity about equity in the context of death review would be beneficial to the county team leads and coordinators.
- Team reviewed the prevention recommendations from the county teams and drafted state team response for each recommendation.
- Membership workgroup met and agreed to share the draft membership spreadsheet with the entire state team for feedback and check in with Cate Wilcox about tools.
- Peer support workgroup led by Kathleen. Volunteers for completing work product needed for next steps (sample agenda, sample email to team members).
- Volunteers for next time include Taylor reading the grounding statement, Robin overseeing the chat, and Emily tracking time thank you in advance for stepping up.
