Statewide Public Campaigns



Heal Safely Campaign

Prescription opioids come with risks and serious side effects and should be a last resort when managing pain. [Heal Safely](#) offers communities throughout Oregon

[Reverse Overdose Oregon](#) is a statewide campaign that gives employers the tools to train their teams on how to use naloxone—the life-saving medication that reverses opioid overdose—as part of workplace safety and preparedness. By providing naloxone training

and resources to employers, Oregon Health Authority is expanding the pool of first responders to overdose and empowering everyday people to save the lives of coworkers and community members who accidentally overdose from prescription painkillers or illicit opioids.

[Save Lives Oregon](#) began in 2020, when the COVID-19 pandemic heightened the overdose crisis and left many families, neighborhoods and communities struggling. In response, a resource hub was launched to

provide more life-saving supplies such as naloxone to organizations and tribal communities on the front lines of harm reduction. With continued support and a growing understanding of the power of harm reduction to save lives, Save Lives Oregon is reducing drug-related stigma and increasing access to programs that support the health and dignity of people who use drugs

Behavioral Health Resource Networks

In November 2020, Oregon voters passed by referendum the [Drug Addiction Treatment and Recovery Act](#), commonly referred to as Measure 110. [Senate Bill 755](#) (2021) established **Behavioral Health Resource Networks (BHRNs)** and [House Bill 2513](#) (2023) further clarified the role of BHRNs. A BHRN is an entity or group of entities working together to provide comprehensive, community-based services and supports to people with substance use disorders or harmful substance use. Each Oregon county and Tribal area has at least one BHRN. Each BHRN must provide trauma-informed, culturally specific and linguistically responsive services. Services include but are not limited to:

- Screening for health and social service needs
- Behavioral health screening and referral for substance use disorder
- Individualized intervention planning
- Low-barrier substance use disorder treatment
- Harm reduction services
- Peer-supported services
- Employment services
- Housing supports
- Referral to appropriate outside services

Removal of X-Waiver Requirement Update

Prior to 2023, a special Drug Enforcement Agency (DEA)-approved [X-waiver](#) certification from Substance Abuse Mental Health Services Administration ([SAMHSA](#)) was required for clinician to prescribe buprenorphine. The U.S. Department of Health and Human Services (HHS) moved to [repeal X-waiver requirements](#) and as part of the [omnibus bill](#) to expand universal access to medications for opioid use disorder (MOUD) treatment.

[Effective now](#), any clinician with a current DEA registration, that includes Schedule III authority, may prescribe buprenorphine for opioid use disorder (OUD). There are no limits on the number of patients a prescriber may treat. However, the simultaneously passed Medication and Access and Training Expansion Act, requires all clinicians applying for or renewing their DEA license to complete a one-time, 8- hour training on treating and managing patients with SUD. Certain providers, such as those board certified in addiction medicine or recent graduates with applicable curriculum, will not have to complete any additional training. This requirement has been effective since June 2023.

Opioid Settlement Funding

Oregon was among many jurisdictions that sought compensatory restitution from damages that resulted from opioid manufacturers' and distributors' criminal actions. Oregon is expected to receive approximately \$333 million in [opioid settlement funding](#) from pharmaceutical opioid manufacturers and distributors through July 2038 and is expected to receive additional funds from other pending lawsuits. Forty-five percent of funds will be distributed based on allocations recommended by the [Opioid Settlement Prevention, Treatment, and Recovery \(OSPTR\) Board](#) established by [House Bill 4098](#) (2022). The remaining 55% of Oregon's settlement funding, approximately \$183 million, will be distributed to cities and counties with populations greater than 10,000 for locally determined allocation.

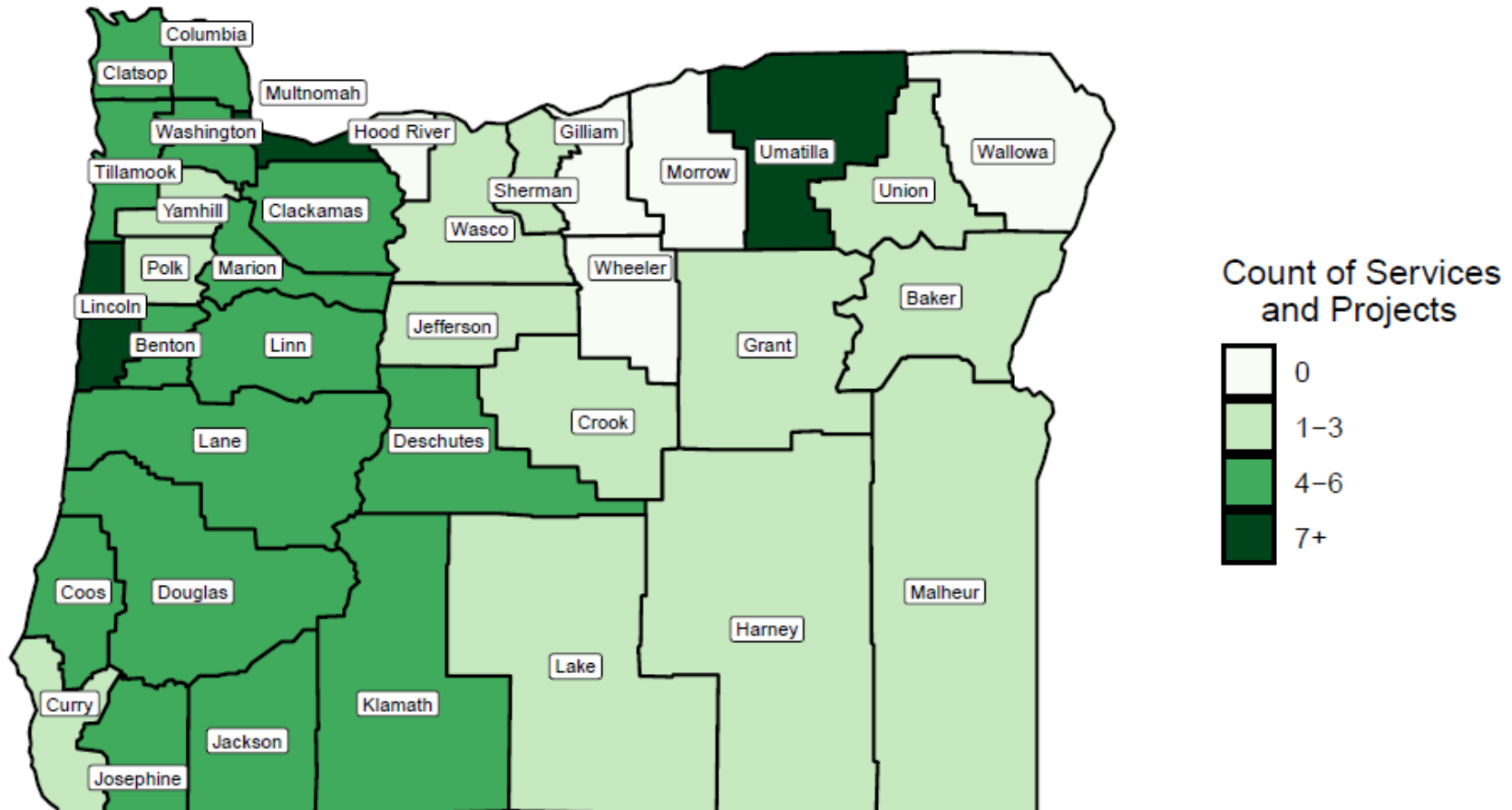

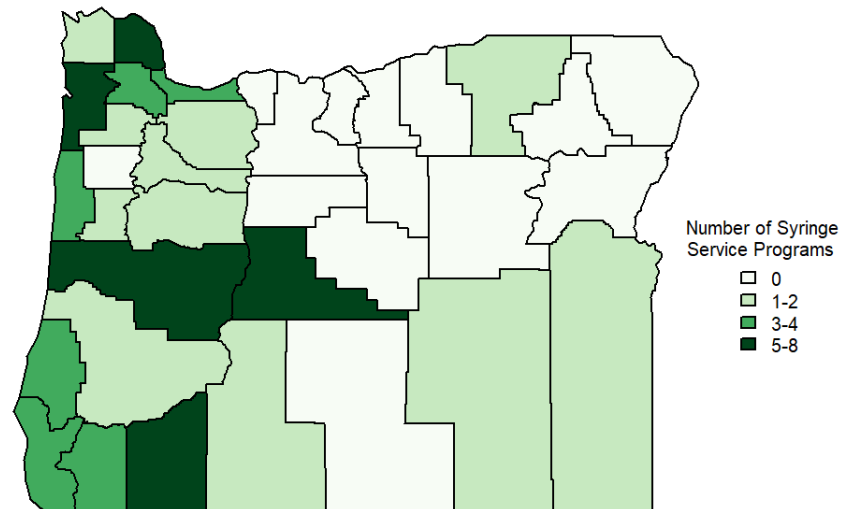

Syringe Service Programs (SSP)

[SSPs](#) are community-based programs for people who inject drugs. SSPs provide a variety of services including free sterile needles and syringes, safe disposal areas, naloxone distribution and overdose education, and access to prevention services such as HIV and hepatitis C testing. Many also provide referrals to services or link with peer programs to offer services. These programs are important in efforts to prevent overdose, HIV and hepatitis C transmission, and hospitalizations for bacterial infections.

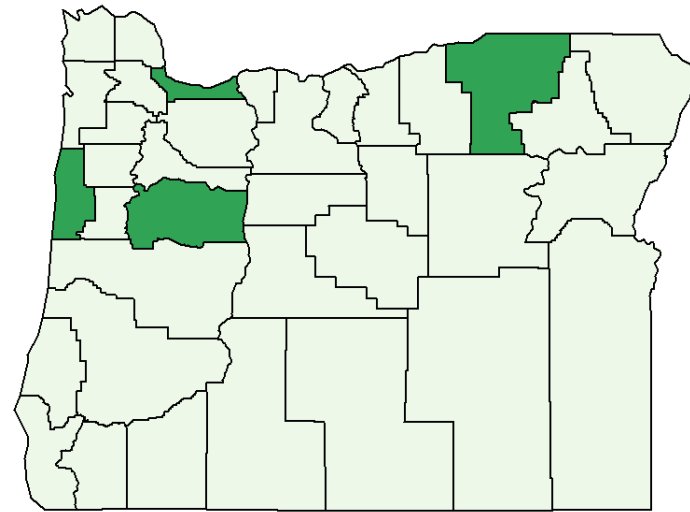

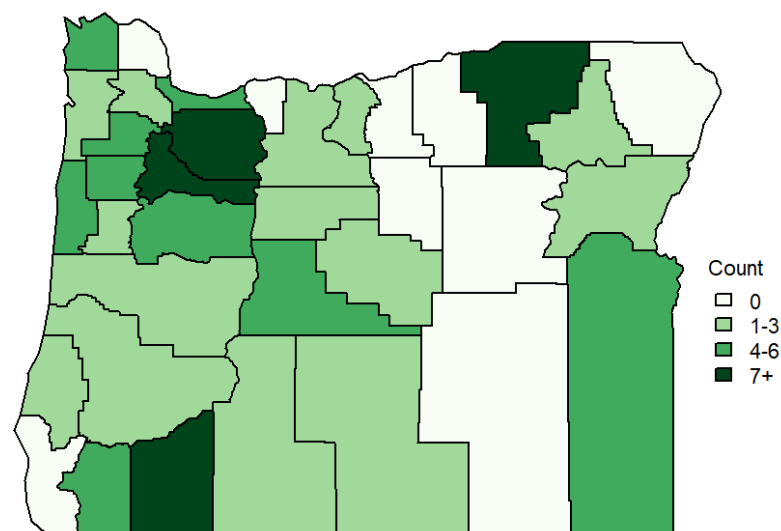

Overdose Detection and Mapping Application Program (ODMAP)

[ODMAP](#) provides near real-time suspected overdose surveillance data across jurisdictions to support public safety and public health efforts to mobilize an immediate response to a sudden increase, or spike in overdose events. It links first responders and relevant record management systems to a mapping tool to track overdoses to stimulate real-time response and strategic analysis across jurisdictions.

Each agency wishing to participate signs a data sharing agreement which is designed to protect the data within the system. Once signed, they can begin uploading data in real time and access to the ODMAP dashboard, which allows users to view nationwide data. This tool is only available to government (state, local, federal, or tribal) agencies serving the interests of public safety and health. ODMAP is funded by the White House Office of National Drug Control Policy's (ONDCP) High Intensity Drug Trafficking Areas (HIDTA) program and there is no cost to agencies who utilize it.

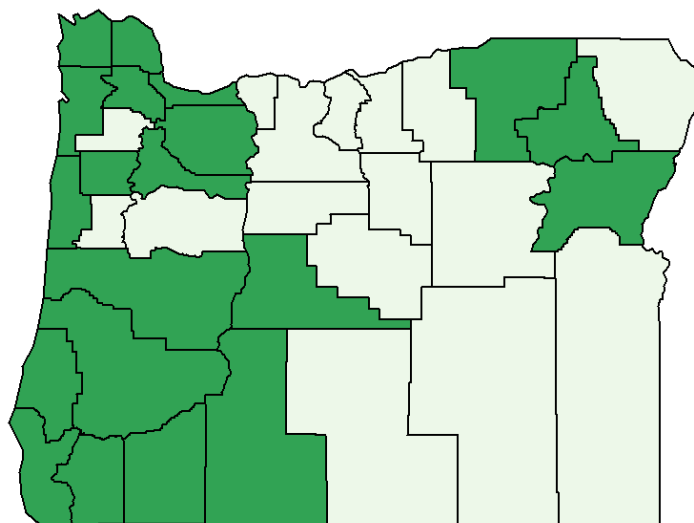
Peer Recovery Initiated in Medical Establishments + HCV/HIV Testing and Linkage to Care (PRIME+)

[The PRIME+ Program](#) merged and adapted two peer-based models: The Oregon HOPE study and the Peer Recovery Initiated in Medical Establishments (PRIME) program, originally funded by House Bill 4143 in 2018. PRIME+ was initially piloted in three counties with funds from the CDC. The program has expanded to 20 of 36 Oregon counties and is now funded by the State Opioid Response (SOR) grant from the SAMHSA.

The PRIME+ Program connects peer recovery support specialists with people who are at risk of, or receiving treatment for, an overdose, infection, or other health related issues related to substance use. PRIME+ peers use a harm reduction approach to engage people at varying stages of behavior change, to provide access to harm reduction supplies; linkage to substance use disorder (SUD) treatment, recovery support, and physical health care; support for infectious disease testing and treatment (particularly hepatitis C); access to community resources to

meet basic needs; and emotional and crisis support. Participants connect to PRIME+ in three ways: Community partners (e.g., emergency departments, healthcare and service providers) make referrals, peers conduct direct outreach (street, encampments, etc.), and individuals self-refer or are referred by friends and family. A robust program support infrastructure includes a monthly peer learning collaborative (with continuing education credits), program implementation guides, an active cross-site message board and resource document repository, weekly peer huddles, monthly supervisor meetings, an online database to document services, promotional templates, enhanced peer supervision for selected sites, and an annual in-person convergence.



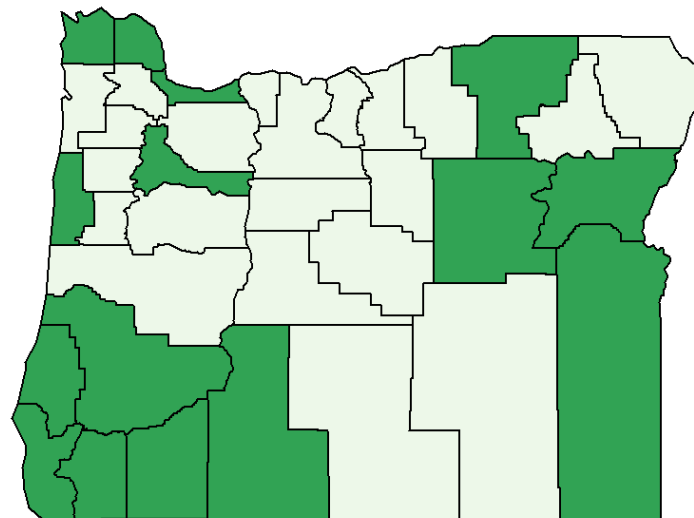

Peer Assisted Telemedicine for Hepatitis C and Syphilis (PATHS)

[PATHS](#) is an expansion of an innovative intervention developed and tested by the [Oregon HOPE study](#) and led by OHSU. OHA is providing funding through the SAMHSA SOR grant to expand this successful model statewide. Peer specialists support people who use drugs or are in early recovery in accessing infectious disease testing, hepatitis C pretreatment screening, and linkage to telemedicine HCV treatment clinicians, and support participants in medication initiation and adherence. OHSU clinicians with specialty experience in working with people who use drugs provide streamlined access to care. The intervention relies on dedicated community-based peer outreach and support, “on-demand” clinical care, and partners positioned to enact systems change. The PATHS expansion includes implementation by PRIME+ and other peer teams and select opioid treatment programs (OTPs) around the state. The PATHS team provides training, technical assistance, and clinical coordination to peer teams and partners implementing the model. Peers around the state have been trained in PATHS; the table below shows sites that have begun providing PATHS to participants.



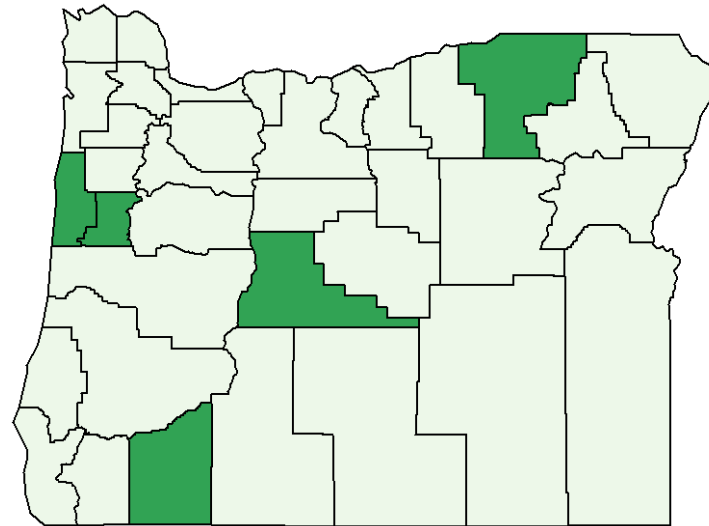

Nurture Oregon

[Nurture Oregon](#) is an integrated care model providing pregnant people who use substances with peer recovery support services, prenatal and postpartum care, substance use and mental health treatment, and social service coordination. The original model (Project Nurture) was piloted in three sites in Portland, Oregon beginning in 2015 and was associated with increased prenatal visits, reduced placement of children in foster care, and cost savings. Oregon Health Authority's (OHA) Behavioral Health Division expanded and adapted the program for sustainable implementation in rural communities. The expansion project, Nurture Oregon, currently includes five rural counties (Benton, Deschutes, Jackson, Lincoln, and Umatilla counties). Enhanced elements have been incorporated such as regular cross-site training and coordination, and site-level technical assistance. Nurture Oregon includes a collaboration with Oregon Department of Health Services (ODHS) Child Welfare in developing training sessions and materials for coordinating Comprehensive Addiction Recovery Act Plans of Care. The expansion project is being formally evaluated by OHSU. OHA is collaborating with Comagine Health to support sites in creating integrated sustainable models to best fit available resources in rural communities and to implement data collection and monitoring systems.

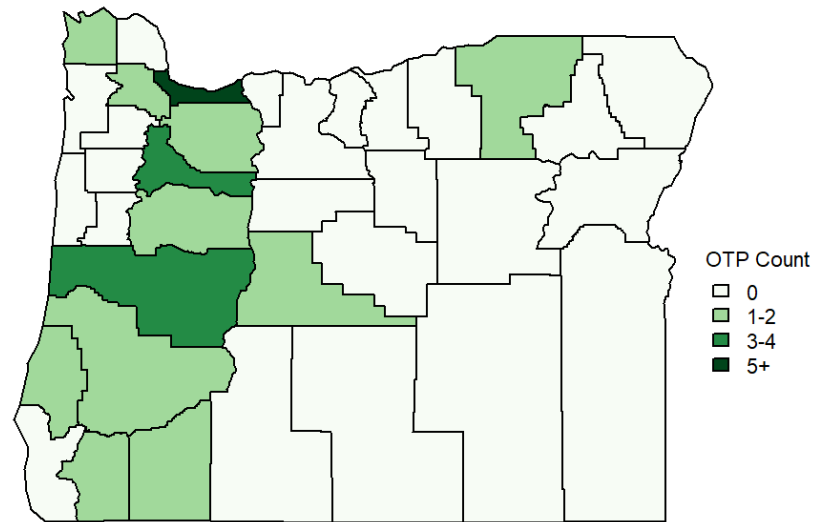

OTPs provide MOUD for people diagnosed with an OUD. MOUD patients also must receive counseling, which can include different forms of behavioral therapy. [SAMHSA's Division of Pharmacologic Therapies \(DPT\)](#), part of the SAMHSA Center for Substance Abuse Treatment (CSAT), oversees the certification of OTPs. OTPs must be certified by SAMHSA and accredited by an independent, SAMHSA-approved accrediting body to dispense opioid treatment medications. All OTPs also must be licensed by the state in which they operate and must register with the DEA.



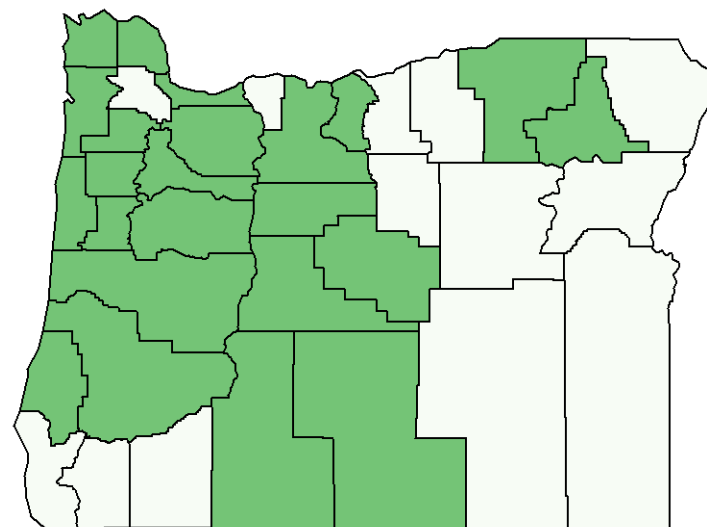

As part of Oregon's CDC Overdose Data to Action (OD2A) in States grant and SAMHSA Substance Use Prevention, Treatment, and Recovery Services (SUPTRS) block grant, the Oregon Health Authority (OHA) Injury and Violence Prevention Program (IVPP) funds LPHAs in 11 regions to support local substance use and overdose prevention efforts. Eleven regional partnerships, covering 23 of 36 counties, are awarded \$1.4 million per funding year to improve local systems for substance use and overdoses prevention, harm reduction, treatment, recovery, and response. The grant funding for this work began in September 2020 and continues through September 2025.



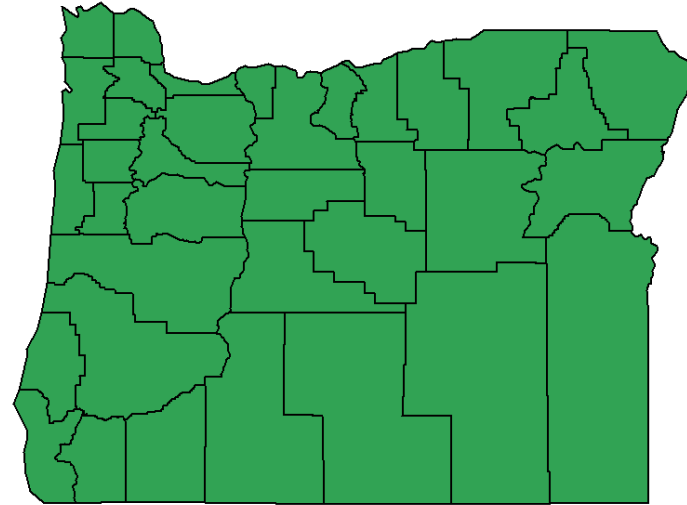

The Oregon Health Authority (OHA) Health Promotion and Chronic Disease Prevention (HPCDP) Section administers funding for ADPEP programs across the state to implement primary prevention services. For the 2025-2027 biennium, most ADPEP programs are funded through the SAMHSA's Substance Use Prevention, Treatment, and Recovery Services Block Grant (SUPTRS BG) and Opioid Settlement Funds allocated by the OSPTR Board. ADPEP programs implement evidence-based interventions targeted at shared risk and protective factors to prevent and reduce the use and associated effects of alcohol, commercial tobacco and other drugs across the lifespan.
