# Did you know that the legal age to purchase tobacco is 21?

In 2018, the Tobacco 21 (T21) law took effect in Oregon, followed by a national increase to the minimum age for tobacco sales in 2019. The T21 law increased the minimum age to purchase tobacco from 18 to 21. Oregon tobacco retailers have a role to play in decreasing youth access to tobacco by not selling to anyone under the age of 21.

### Tips for checking to see if someone is under the age of 21.

- Ask to check the ID of any customer who looks younger than 30 years old—if you
  are unsure, ask for their ID every time.
- In all 50 U.S. states and the District of Columbia, driver's licenses and IDs issued to individuals under the age of 21 are vertically oriented. Look for the red box on the right side of Oregon's ID that shows when the person will be 21.
- Consider using an age verification system and have staff check every ID, regardless
  of how old the customer appears.


# What are the top three compliance inspection violations?

The Tobacco Retail License (TRL) Program inspects every retailer in Oregon at least once per year. Inspections include making sure retailers are not selling to people

under 21, while additional inspections check for compliance with all tobacco retail sales laws. These are the top three compliance violations that the TRL program sees and tips for preparing your retail store before your inspection.

### #1 Violation: Properly displaying required state signage

- Retailers are required to display the Tobacco 21 Oregon State Notice posting (ORS 431A.175, ORS 431A.178). Failure to post the state sign (or a notice that is substantially similar) in a location clearly visible to the seller and purchaser may result in a violation.
- Below is the Tobacco 21 Oregon State Notice sign that must be posted in every retailer that sells tobacco and inhalant delivery systems (IDS).

# #2 Violation: Inhalant Delivery System (IDS) child-resistant packaging requirements

 It is federal and Oregon law that IDS, also known as e-cigarettes, must be sold in child-resistant packaging.

- Retailers who sell e-cigarettes, liquid nicotine containers, non-nicotine liquid containers, and fillable inhalant delivery system(s) that are packaged with liquid nicotine container(s), the product must be in child-resistant packaging from the manufacturer.
- The distributor or manufacturer should provide testing documentation, called, a "certificate of conformity" verifying that the packaging is child-resistant by the standards in the Code of Federal Regulations (16 CFR 1700.20).
- If you are not able to show this documentation to an OHA inspector during your annual routine inspection, it may result in a violation and civil penalty.
- Here are some tips to help prepare for your next inspections:
  - Keep all certificates of conformity in a place where all staff and managers on duty know where to find them.
  - Check to see that you have certificates of conformity for each product each time you get a new shipment.
  - Review certificates often to ensure you have one for each product in your store.

### **#3 Violation: Self-service tobacco products**

- Law requires that all tobacco products must be kept behind the counter in an area only employees can get to OR in a locked case.
- Tobacco and IDS products that customers can get without the help of a store clerk may result in a violation. An exception to this is if the business prohibits customers younger than 21.

# House Bill 3940 passes in Oregon State Legislature

The Oregon Legislature recently passed House Bill 3940, which creates a new tax on the distribution of oral nicotine products in the state. The tax is effective beginning January 1, 2026, and licensed distributors will begin reporting the tax on their first 2026 quarter returns. Oral nicotine products in packages of 20 or fewer units will be taxed at \$0.65 per package. For packages containing more than 20 units, the tax will be calculated at \$0.0325 per unit. These taxes will help fund wildfire relief efforts in Oregon. The Department of Revenue will be publishing further guidance in the coming months on their website,
