Peds Ready EMS sets the standard for EMS transport agency pediatric readiness. Completing the steps necessary to participate in Peds Ready EMS will improve agency readiness to treat pediatric emergency medical and trauma patients. This is a voluntary recognition program, and there is no fee to participate. <u>Apply today!</u> The online application should take about an hour to complete. Once the application has been reviewed and accepted, the EMS transport agency will receive a recognition certificate and ambulance decal(s).

Support Sensory, Communication, and Social Differences

The Autism Society of Oregon mailed or hand-delivered approximately 650 Sensory Kits to agencies: one kit per licensed ambulance. The Sensory Kits can be used with patients of all ages to support sensory, communication, and social differences.

A recorded orientation session, slides, and resource document are available on the Oregon EMSC <u>website</u> - Prehospital Pediatric Emergency Care Coordinators section. The orientation included an overview of the Sensory Kit, how to use the kits to support autistic individuals and others who need emergency services, a review of some of the basic hallmarks of autism spectrum disorder, and information about the services provided to the community by Autism Society of Oregon.

Oregon Poison Center Training

Participants will learn about poison control centers, identify common poisons and prevention strategies, learn what to do in case of a poisoning, and how to share your knowledge with others. The course is free, virtual, and self-paced. Passing the final post-test (80% score or better) will generate a certificate of completion. The training is available on the poison center's <u>website</u> or by going directly to the training <u>link</u>.
