Pediatric Advanced Life Support Program (PALS)

Overview

The American Heart Association Pediatric Advanced Life Support course is based on scientific evidence from the AHA Guidelines for CPR and ECC. The goal of the PALS course is to aid pediatric health care providers in developing the knowledge and skills necessary to efficiently and effectively manage critically ill infants and children, resulting in improved outcomes. Skills taught include recognition and treatment of infants and children at risk for cardiopulmonary arrest, the systematic approach to pediatric assessment, effective respiratory management, defibrillation and synchronized cardioversion, fluid bolus administration and effective resuscitation team dynamics.

Desired outcomes

- Recognize and manage a child in respiratory distress or failure and/or compensated or hypotensive shock
- Describe key elements of resuscitation team behaviors and explain why the foundation of successful resuscitation includes both mastery of basic skills and effective team dynamics
- Prevent further deterioration of the child's condition during the stabilization and transfer phases of care

Target audience

This course targets pediatricians, emergency physicians, family physicians, physician assistants, nurses, nurse practitioners, paramedics, respiratory therapists and other health care providers who initiate, direct or participate in advanced life support during pediatric emergencies.

PALS Provider Status

Upon successful completion, participants will receive an AHA-issued PALS Provider Card, which is valid for two years after the issue date. To maintain current status, all providers must complete a course prior to the expiration date and provide proof of current AHA-issued PALS Provider Status at the course.

AHA BLS Provider certification/recertification option

All PALS students must demonstrate high-quality basic life skills (BLS). This course offers an optional BLS certification component. Current BLS certification is not required to take advantage of this option.

In order to obtain an AHA BLS Provider card as a part of the PALS day, *students must complete the AHA HeartCode BLS Online Part 1 course within the 60 days preceding their PALS course date.* BLS practice and skills validation will be completed the day of class.

The online course completion certificate is required for both new and renewal certifications and must be brought to class. Instructions on how to access the online course will be provided upon registration.

1. There is an AHA fee for the online course.
2. The PALS day is the same length, even if the student does not become BLS-certified.

Pediatric Emergency Assessment, Recognition and Stabilization (PEARS)

Overview

The AHA PEARS (Pediatric Advanced Emergency Assessment, Recognition and Stabilization) Course has been updated to reflect new science in the 2015 AHA Guidelines for CPR and ECC. In this classroom-based, instructor-led course, students learn how to use a systematic approach to quickly assess, recognize the cause and stabilize a pediatric patient in an emergency situation.

During PEARS training, students interact with real patient cases and realistic simulations and animations to assess and stabilize pediatric patients experiencing respiratory and shock emergencies and cardiopulmonary arrest. PEARS prepares students to provide appropriate lifesaving interventions within the initial minutes of response until a child can be transferred to an advanced life support provider.

Course content

This one-day course is available to those taking PEARS for the first time and for those currently certified.

- Pediatric assessment
- High-quality infant and child basic life support (BLS), including skills testing
- Recognition and management of respiratory problems
- Recognition and management of shock
- Recognition and management of cardiac arrest

- Resuscitation team concept
- Prevention of further deterioration of the child's condition during the stabilization and transfer phases of care

Target audience

PEARS is for health care providers who might encounter pediatric emergency situations during their work, but would not direct advanced life support during pediatric emergencies.

PEARS Provider status

Upon successful completion, participants will receive an AHA-issued PEARS Provider Card, which is valid for two years after the issue date. To maintain current status, all providers must complete a course prior to the expiration date.

AHA BLS Provider certification and recertification option

All PEARS students must demonstrate high-quality BLS skills. This course offers an optional BLS certification component. Current BLS certification is not required to take advantage of this option. In order to obtain an AHA BLS Provider Card as a part of the PEARS day, students must complete the AHA HeartCode BLS Online Part 1 course within the 60 days preceding their PEARS course date. BLS practice and skills validation will be completed the day of class.

The online course completion certificate is required for both new and renewal certifications and must

Neonatal Resuscitation Program (NRP)

Overview

The Neonatal Resuscitation Program (NRP), based on American Academy of Pediatrics (AAP) and American Heart Association (AHA) recommendations, offers an algorithm-based approach to the immediate care and resuscitation of the stressed or sick neonate. This course is based on the seventh edition NRP course materials, released in 2016.

Program objectives

Upon completion, participants will gain the knowledge and skills for neonatal resuscitation.

Target audience

This course is for health care professionals who might respond to a neonatal emergency at the time of delivery.

NRP provider status

Upon successful completion, participants will receive an AHA/AAP-issued NRP card, valid for two years.

Online examination requirement

All students must successfully complete the online examination within 90 days before their NRP course and must bring proof of their completed test on the day of the course. The NRP course offered at Randall Children's Hospital at Legacy Emanuel assumes the student has mastered the written material and proceeds directly to skills stations and megacode testing. Instructions on how to access the online examination will be provided to you upon registration. Please note that there is an AAP fee for the online examination and that the AAP offers up to 9.0 CME, CE, CRCE or CECBEMS contact hours for completion of the online course.

S.T.A.B.L.E. Learner Course

Overview

The S.T.A.B.L.E. Learner Course is designed to provide health care professionals with knowledge specific to stabilizing neonates during the post-resuscitation/pre-transport stabilization period. The mnemonic S.T.A.B.L.E. was designed to help providers remember the actions required to stabilize an infant. The goal of the course is to develop a uniform approach to stabilization prior to transport to improve the outcome of the sick neonate.

Program objective

Provide guidelines for post-resuscitation/pre-transport stabilization for health

care professionals in a practical format designed for quick recall

Target audience

The S.T.A.B.L.E. program is designed for all health care professionals who provide support to sick neonates prior to transport. Physicians, midwives, nurse practitioners, nurses, respiratory therapists and paramedics are encouraged to take this course to supplement their knowledge base to potentially improve neonatal outcomes.

CE hours

Four to eight contact hours are available depending on course selection (full or recertification course).

S.T.A.B.L.E. Physical Exam and Gestational Age Assessment

Overview

The S.T.A.B.L.E. Physical Exam and Gestational Age Assessment supplements the S.T.A.B.L.E. Learner Course. Numerous photos, illustrations and animations make difficult concepts easy to understand. This assessment is highly visual, unique and based on the revised Ballard exam.

Program objectives

Upon completion of the program, participants will gain an understanding of the principles of physical exam and

gestational age assessment of the neonate, both term and preterm

Target audience

The S.T.A.B.L.E. Physical Exam and Gestational Age Assessment is designed for neonatal nurses, pediatric interns, residents, respiratory therapists, physicians and all health care providers involved in the care of neonatal patients.

CE hours

Available contact hours include 3.5 contact hours for the course

Pediatric Tracheostomies, Mechanical Ventilation and Respiratory Support Equipment

Overview

This four-hour course for the pediatric acute care nurse provides an overview of the anatomy and physiology of the respiratory system and a review of respiratory deficits and why mechanical ventilation is needed. An overview of home ventilators, tracheostomy tubes, oxygenation, humidification and suctioning is provided. Hands-on practice with equipment and skills check-off are included.

Course goals and objectives

1. The participant will be able to describe the indications for mechanical ventilation in the pediatric patient.
2. The participant will be able to describe the hazards and complications in the pediatric patient associated with mechanical ventilation and actions to avoid or remedy these hazards and complications.
3. The participant will be able to describe and demonstrate the use of respiratory support equipment, including airway clearance and alarm recognition, in the pediatric population.
4. The participant will be able to describe the function and type(s) of artificial airways utilized with mechanical ventilation.

Key points

- Review of anatomy and physiology of respiratory system
- Overview of respiratory deficits and why mechanical ventilation is needed

- Overview of ventilators, tracheostomy tubes, humidification, suctioning and oxygenation equipment
- Practice with equipment, especially alarms
- Return demonstration of working with equipment (check-off skills demonstrated)

Child Life Course

Overview

This course is designed to provide health care providers at all practice levels with the latest information from child life specialists. We will cover how to help pediatric patients and families feel more comfortable and more in control of their health care experience in any practice setting.



Program objectives

- Brief overview of child development by age; review natural coping skills, discuss various hospital and clinic stressors that impact children, and learn about age-appropriate interventions to help improve a child's health care experience.
- Provide best practice techniques on how to support a child during an exam, test or procedure using the four non-negotiables: topical anesthetics, comfort positions, age-appropriate distraction and sucrose for infants 0–12 months of age.
- Discuss and demonstrate age-appropriate distraction, identify items to include in a distraction kit and provide a list of resources to find distraction items.
- Increase knowledge of how to prepare a child for an exam, test, procedure or surgery using age-appropriate child-friendly language, medical play with real medical equipment, medical play kits and using body books for explanations and information.

Overview

Each on-site experience is scheduled based on the availability of the instructors and requested clinicians providing the training.

- Stabilization of the Neonate or Pediatric Patient for Transport (KIDS Team)
- Pediatric Acute Care
- Newborn Stabilization and Care of the Higher Risk Newborn (NICU)
- Care of the Critically Ill Child (PICU)
