The modified triennial onsite agency review of Malheur County Health Department was conducted between April 17 and May 12, 2017. The Oregon Health Authority Public Health Division reviewed county public health programs for compliance with state and federal public health laws and compliance with the Financial Assistance Agreement. This review was modified as part of a multi-year transition to a regional triennial review schedule and because the full triennial onsite agency review was conducted one year prior.

The review included the appraisal of items in 17 program areas, listed below. Program areas with compliance findings are indicated with an asterisk.

Malheur County Health Department received Federal, state and other funds of \$424,373 including \$250,000 for the WIC Program for fiscal year 2016. The Health Department also received \$59,186 General Fund and \$34,378 Other Funds.

PROGRAM OVERVIEW AND STRENGTHS

Babies First! & Perinatal

In less than one year since the full triennial review was completed in June 2016, significant changes have occurred, including a reduction in the number of employed Malheur County Health Department (MCHD) staff members and a hiring freeze that has prevented hiring new staff to fill vacant positions.

Commendable leadership and dedication has been exhibited by Rebecca Stricker, RN, Home Visiting Coordinator and Angela Gerrard, Administrator. They and other MCHD staff are working diligently to continue to provide needed services to families, primarily women and children.

Communicable Disease

Malheur County Communicable Disease (CD) investigations are completed by CD staff. There has been some transition and changes in staff that has affected communicable disease investigations. In the last year and after the last review, 142 disease conditions were reported: 90 Hepatitis C, 18 campylobacter, 3 salmonella, 3 E.coli, 2 Hepatitis B (chronic), 2 West Nile virus cases and 2 reported outbreaks.

Due to other competing priorities, and staff-related transitions, the CD team needs to improve in a number of areas. It is important to create cases on a timely basis and investigation should not be delayed. Good relationships have been developed with the Long Term Care Facilities for reporting purposes and infection control guidance.

Drinking Water Services

The Drinking Water Program provides oversight and services to public water systems, resulting in reduced health risks as well as increased compliance with drinking water monitoring and maximum contaminant level requirements. The Drinking Water Program reduces the incidence and risk of waterborne diseases and exposure to hazardous substances potentially present in drinking water supplies for consumers. Services provided through the Drinking Water Program include investigation of occurrences of waterborne illness, drinking water contamination events and emergencies, response to spills, response to OHA alerts, inspection of water system facilities (surveys), and resolving compliance issues with systems identified by OHA as Priority non-Compliers (PNCs). The Drinking Water Program reports data to, and monitors data from, OHA Drinking Water Services (DWS) to meet State and Federal Environmental Protection Agency (EPA) Safe Drinking Water Act program requirements.

The Drinking Water Program staff are committed to promoting public health and taking actions to protect public health. Staff maintain professional working relationships with the 12 water systems they oversee. Staff attend all state-sponsored trainings and consistently reach out to DWS for technical support.

Fiscal

It appears that the Malheur County Health Department has sufficient internal controls to adequately safeguard assets, to detect and prevent errors in a timely manner. The operation is fairly organized and efficient with a commitment to quality, fairness and accuracy.

Food, Pool and Lodging Health and Safety

Malheur County Environmental Health is doing an excellent job of providing Environmental Health services to the community. The inspection rates for licensed facilities are good in all program areas except for Organizational Camp program.

Craig Geddes and Eric Evans have been state standardized and satisfactory completion and maintenance of the standardization process complies with the field review portion of the triennial review. Staff exhibited good communication skills with operators and employees of the food service facilities during the standardization certification.

Health Security, Preparedness and Response

Malheur County Health Department's (MCHD) Emergency Preparedness Program is currently coordinated at .5 FTE, by Katarina Ferber, who also serves as a Public Health Nurse. Additionally, the program is supported by approximately .25 FTE, with the responsibilities being shared as part time duties across various other positions within the Department.

MCHD's Public Health Emergency Preparedness (PHEP) Program demonstrated many notable strengths, including the following examples:

- MCHD's willingness to support the region as an emergency immunoglobulin (IG) host site continues to strengthen local emergency response capabilities and ensures protection for the health of the community during a communicable disease event.
- In addition to maintaining an All-Hazards base plan, MCHD is engaged in the following planning efforts:
 - MCHD recently submitted updates to Emergency Support Function (ESF) 8 to County Emergency Management for inclusion in the updated County Emergency Operations Plan, signed April 19th, 2017.
 - MCHD has completed an Ebola Plan, which has been included as an annex to All-Hazards base plan.
 - MCHD is also participating in the development of a disaster behavioral health support plan in collaboration with Local Mental Health Authority, Lifeways.
- MCHD maintains a Multi-Year Training and Exercise Plan, which is included in PHEP Annual Workplan.
- All MCHD staff receive IS 100 & 700 training, at a minimum.

- MCHD successfully conducts both routine and emergency communications with the community at large.
- MCHD's outstanding relationship with local Emergency Management, and the larger response community as a whole, provides enhanced opportunities for coordination in planning, training, exercise and response activities. As a result, the Emergency Preparedness program is performing very well.

Immunizations

Malheur County Health Department runs an exceptional immunization program under the supervision of Hilary Heller. The clinic had no compliance issues in the VFC program site visit. Malheur County staff do a remarkable job providing a resource to clinics in the county. They have a strong commitment to building relationships in their community which is made evident by their understanding of their population's needs and the length they go to fill those needs. They also do an excellent job managing their vaccine as shown by achieving over 95% accountability for their vaccine stock.

Reproductive Health

Reproductive health services are provided Monday through Friday with appointments with an RN. Appointments are available with the medical provider every Friday. Due to the long wait time to see the medical provider, Malheur County Health Department (MCHD) offers a half a day of walk-in appointments on the last Friday of the month.

Clinical services are provided following national standards of care which ensures clients are receiving quality family planning services. All birth control methods are available so clients are able to choose the best contraceptive method for themselves.

MCHD continues to provide excellent family planning care with emphasis on counseling, education and access to long acting reversible contraceptives. Despite the challenges with budget, staff continues to provide every client the services that they need.

Vital Records

The Malheur County Vital Records office serves their community by offering a local office where certified copies of birth and death records are available to order by authorized individuals. The county is limited to providing this service for the

first six months after the event, whether birth or death. Orders placed in this office are typically completed within one day.

The Malheur County Vital Records Office consistently provides excellent customer service to their customers and partners throughout the community. The county registrar, Peggy Winslow, ensures all areas of the vital records office run smoothly and securely.

The Malheur County Office of Vital Records provides a positive linkage between the community and the state vital records office. Records and reports are handled with careful attention to maintaining security and confidentiality. Partners within the community, the local hospital and local funeral homes, visited during this trip report great relationships and excellent service from this office. State staff that have contact with the county report a similar high regard for the work of this office.

<u>WIC</u>

WIC's mission is to safeguard the health of low-income women, infants, and children up to age 5 who are at nutrition risk by providing nutritious foods to supplement diets, information on healthy eating, and referrals to health care. Delivering high quality nutrition services is essential in not only carrying out this mission, but also ensuring that WIC continues to be the premiere national public health nutrition program.

The WIC program has demonstrated the following strengths:

- 1. Malheur County WIC staff has demonstrated commendable resiliency and leadership during a period of transition after the retirement of their WIC coordinator.
- 2. To support breastfeeding efforts, Malheur County WIC has made improvements to clinic operations and encourages postpartum women to be seen in clinic shortly after delivery to support breastfeeding and address health and nutrition concerns.

3. Malheur County WIC collaborated with community partners to receive training and implement an innovative group education: Parent Café, which exemplifies participant centered services and education.

WIC Farm Direct Nutrition Program (FNDP)

The Oregon Farm Direct Nutrition Program (Farm Direct) provides WIC families with FDNP checks once a year to purchase fresh, locally-grown fruits, vegetables and cut herbs directly from local farmers.

Malheur County WIC has done an outstanding job of bringing together local area farmers and WIC participants at the WIC clinic to build community relations and effectively utilize the FDNP checks as demonstrated by a 2016 redemption rate of 75.19%, exceeding the 2016 statewide average of 63.92%.

QUALITY ASSURANCE RECOMMENDATIONS

Communicable Disease

- 1. Recommend timely case creation.
- 2. Recommend timely interview of all cases including animal bites.
- 3. Recommend improving on days to first interview attempts.
- 4. Recommend completing all risk factor questions for all cases requiring interview.
- 5. Recommend investigating all reported outbreaks.
- 6. Recommend attempting lab confirmation (5 specimens collected) for all outbreaks.
- 7. Recommend conducting case finding for all potential common source outbreaks.
- 8. Recommend completing epi curve for all potential common source outbreaks.
