

2016 CCO Incentive Measure Benchmarks

Updated October 7, 2016

The Metrics & Scoring Committee has selected the measure set, adopted updated benchmarks and improvement targets, and selected challenge pool measures for 2016, reflecting improved CCO performance. Challenge pool measures are indicated with an asterisk in the measure column below.

Note several measures are still pending Committee discussion. The Committee will select the remaining 2016 benchmarks at an upcoming meeting; OHA will update this document once all 2016 benchmarks and improvement targets have been selected.

All 2016 improvement targets will be calculated on CY 2015 final performance; OHA will release 2016 improvement target calculations for CCOs in summer 2016.
