A new “ECR” button was added to the top of the “REALD” screen:

- This button will **ONLY** appear if the person has related eCR record(s)
- When you click on this button, it will open a new window showing those related eCR record(s)
- This was created so you can check if any relevant REAL-D data was reported via eCR
