Subject: EDI Registration Contact Changes

The HIPAA Transactions and Codes Sets Project was jointly funded by CMS and OMAP. The Project, CMS funding and most of the staff support ended December 31, 2005. However, the new work the HIPAA requirement created continues. To meet this continuing need OMAP has transferred this work to the EDI Outreach and Training Team.

The EDI Outreach Team will staff the phones in person between the hours of 8 a.m. and 5 p.m., Monday through Friday, excluding holidays. You may leave voice messages 24 hours a day for return calls. The EDI Testing Team staff support will continue as it has been for at least the next six months. Our commitment to return communications within one business day continues.

Trading Partners can reach either the Registration or Testing Team by calling (503) 947-5347 or (1-800) 422-5047 and pressing Option 2.

Trading Partners calling either number will reach an EDI Outreach Team member who will triage the call, forwarding them to the Testing Team when appropriate.

The e-mail address, <dhs.hipaatesting@state.or.us>, will stay the same for those wishing to register as an EDI user, as well as for those who need help with testing.
