Important Billing Reminder about accepted NPI claim forms

ADA, UB, 505 Accepted Claim Forms

Starting May 23, 2007, DMAP will only accept and process the UB-04, ADA 2006, and DMAP 505 (rev. 2/07) claim forms for institutional, dental, and professional Medicare crossover claims. **On and after this date, any claim DMAP receives using older form versions will go back to the provider to resubmit on the correct form.**

CMS 1500 Accepted Claim Forms

Starting June 1, 2007, DMAP will only accept and process the 8/05 version of the CMS 1500 claim form. **On and after this date, any claim DMAP receives using the 12/90 claim form will go back to the provider to resubmit on the correct form.**
