DHS has arranged two more Sunday sessions specifically for you to learn about changes coming with the replacement MMIS (see dates at right).

The Oregon Board of Pharmacy has approved this training for four hours of continuing education credit for pharmacists and technicians licensed in the state of Oregon.

- When the replacement MMIS goes live, Electronic Data Systems (EDS) will take over the Pharmacy Benefit Management (PBM) functions from First Health.
- At this training, you will learn about changes to prior authorization, Point of Sale (POS), ProDUR messages, State Maximum Allowable Cost dispute resolutions, and more.
