Message: In December 2008, DMAP will mail the attached letter to all providers telling them that numerous rules will be revised as follows:

Effective November 14 through December 8, 2008, one rule in the Pharmaceutical Services is temporarily adopted for this time period only. This is regarding MMIS “conversion week” allowing clients to continue to receive drugs.

Effective December 1, 2008: MMIS related rules are revised.

Effective December 28, 2008, DMAP will permanently adopt temporary rules in the School-Based Health Services and Targeted Case Management Services programs. MMIS related rules will be adopted in the SBHS program.

Effective January 1, 2009, DMAP will permanently adopt, amend or repeal various program rules. See attached letter.
