**Hospital:** DMAP temporarily amended 410-125-0141 and 410-125-0195 to reflect rate changes in outpatient and inpatient hospital services for Diagnosis Related Grouper (DRG) hospitals. DMAP intends to file these rules permanently on or before October 28, 2009.
