# Dental provider update

## Medicaid dental information on the Web

To comply with the Children's Health Insurance Program Re-Authorization Act (CHIPRA), the Division of Medical Assistance Programs (DMAP) submitted the following lists to the federal Health Resources Services Administration (HRSA) for posting on the *Insure Kids Now!* Web site:

- **A list of Oregon Medicaid dental providers:** DMAP has submitted a list of dental providers organized by participating OHP dental care organization (DCO).
  - For each dental provider, DMAP submitted the information required by CHIPRA (see box at right).
  - Providers contracted with more than one DCO will be listed more than once.
  - Oregon's list is compiled from reports submitted by the DCOs; it does not include non-contracted providers who bill DMAP on a fee-for-service (FFS) basis.
- **A list of the dental benefits** Oregon provides under Medicaid and the Children's Health Insurance Program.

This information will be available on the *Insure Kids Now!* Web site at [www.insurekidsnow.gov](http://www.insurekidsnow.gov) beginning August 4, 2009.

After that, DMAP is required to submit updated provider information quarterly and benefit information annually.

DMAP will submit information about FFS dental providers in future updates to HRSA.
