**Message:**

The OHP application (7210) and the online application (7210W) were recently revised, along with the Green Booklet (9025). The English versions are now in use in the revised format.

**The 7210 and the 9025 are now available in the new print format in Russian, Spanish and Vietnamese.** There will not be a mass-distribution of the new versions in these languages. Branch offices can place an order with OCE for the number of application packets needed, and upon receipt of the revised packets in these languages, recycle any outdated stock. Because the new materials reflect various policy changes and improvements for clients, please submit your order for the revised materials now. While workers will continue to accept and process the older version of the application, recycling older stock will help to ease the transition period.

The original plan was to release the online (7210W) version and the 7210 in all of these languages at the same time. However, due to last minute revisions to the 7210W, the 7210 is being released first, and the updated 7210W's will follow in a few weeks.
