Crossroads visitors begin completing OSH Visitor Applications

For the safety and security of Oregon State Hospital (OSH) patients, visitors and staff, OSH has determined that all patient visitors will need to complete a visitor application form. OSH will conduct a criminal history check.

As a current Crossroads visitor:

- Your visitation will not be impaired or interrupted during this transition process.
- Visitor Applications are available:

 - At the Communication Center in the main lobby; or
 - By calling the Communication Center at 503-945-2800 to have an application mailed to you.

Instructions:

- Make sure your application is legible, complete and correct. The hospital will not approve applications if they cannot be read or if information is missing, inaccurate or untruthful.
- Your signature is required on the application.
- Return your application to the Communication Center:
