PEBB Flu clinic

Get A Flu Shot.com will again be providing flu shots in State agency and university worksite locations this fall. Flu shots are being provided in conjunction with PEBB medical plans as part of PEBB benefits

Flu shot clinics will be held from mid-September through December.

Flu vaccinations are available as a covered benefit to all PEBB members and covered dependents 9 years of age or older. Nasal spray flu vaccine (FluMist) will NOT be available in 2016/17 season.

CDC's Advisory Committee on Immunization Practices (ACIP) voted that live attenuated influenza vaccine (Flumist), also known as the "nasal spray" flu vaccine, should not be used during the 2016-2017 flu season

There is no cost for the flu vaccination to any person covered by a PEBB insurance plan. Any employee who is not covered by PEBB insurance (e.g., new hires, contract workers) may pay for and receive a flu shot. The cost is \$30. cash, check or credit cards are accepted.

At the time of service, PEBB members will need to show their insurance card and complete a one page insurance form. Insurance forms will be emailed in advance to all State worksites with the confirmation notice of their scheduled clinic. PEBB members are encouraged to complete these forms in advance of their clinic.

If an Agency allows family members to participate, children as young as 9 years of age may receive a flu vaccination. At least one Parent or Guardian must be present at the time of vaccination and sign a consent form for dependents younger than 15 years of age. Consent forms will be provided on the day of the flu shot clinic.

A minimum of 20 participants is required for a worksite to schedule a flu shot clinic. To schedule a clinic at your worksite, please submit one of the following:

- (1) An email request to office@getaflushot.com; OR
- (2) A request via our website: www.GetAFluShot.com. On our website click on 'To Request Service' on the left side of the screen then complete the form at the bottom of the page.

Your request should include the following information:

- Facility name & address.
- Contact person's name (first and last), title, phone number and email address
- If possible, alternate contact name, title, phone number and email address
- Provide the approximate number of staff in the facility, and if known, the approximate number that might be receiving flu shot vaccination.

• If you are in a facility that hosts more than one agency, please provide that information. This is extremely important in coordinating schedules. • **Indicate scheduling preferences, i.e., which day of the week or time of day. Please be as flexible as possible. We can accommodate Monday through Friday requests.**

Scheduling and coordinating is a very complex and labor intensive process. **The most efficient way to communicate is via email to office@getaflushot.com or via our website.** During the initial scheduling period, longer delays may occur before getting a response. Your patience will be greatly appreciated. When an urgent response is needed, call GetAFluShot.com at 503.258.9800 and ask for Christy, Hassan or Pam. (Anyone will be able to assist you) Flu shot schedules will be posted on the PEBB website <http://www.oregon.gov/OHA/PEBB/flushots.shtml> and updated regularly.

PEBB members will be able to come to any listed clinic. **Please note, if your agency is not able to accommodate members from other agencies your site will not be listed on the website.** All immunizations administered by a licensed nurse, R.N. or L.P.N.
