	Peanut spreads are not allowed on WIC. The word "Natural" is not an indicator that the product is peanut butter. Always check the Food List.	
8.	If your store is out of the infant formula listed on customer's benefit list, you may give the shopper a rain check or substitute a different formula.	False
	Rain checks or substitutions are never allowed on WIC.	
9.	If the shopper enters their PIN incorrectly four times, the card will be locked.	True
	The customer can call the customer service number on the back of the card to reset their PIN before the 4 th attempt. After a 4 th incorrect PIN, the card will be locked until midnight.	
10.	The use of scan codes, codebooks, or clipboards of WIC-authorized UPCs at the check stand is not allowed.	True
	Always scan the UPC barcode on the product or manually enter the UPC.

11.	If the shopper returns WIC food items and wants a cash refund or store credit, you should honor the customer's request.	False
	Refunds for cash or store credit are not allowed for WIC purchases. Damaged or recalled products may be replaced with the same item. When in doubt whether an item was bought with WIC, follow your store's return policy.	
12.	If an item is not in the Approved Products List (APL), you should attempt to find a creative solution or override to allow the purchase for the customer.	False
	Products missing from the APL should be submitted to the State WIC Office. Any work-around to allow a product that isn't going through could result in a violation.	
13.	Stores are required to offer the final receipt to shoppers for WIC transactions.	True
	The final receipt is required because it gives the shopper a record of what WIC products were purchased and at what price. It also shows their beginning and ending benefit balance.
