OHCS Agencywide Bill

<u>Senate Bill 892</u> – formerly LC 550, OHCS General Statute Cleanup. Look out for a small technical amendment and the public hearing to be scheduled soon in the Senate Housing and Development Committee

OHCS Budget Update

OHCS budget was before the <u>Joint Committee on Ways and Means on Transpiration and Economic</u> <u>Development</u> this week. *Written testimony due by Saturday at 1 PM!*

Early Session Housing Package Update

Governor Kotek and legislative leadership have committed to passing and signing the package by March 17th

- <u>HB 2001</u> and <u>the -11 amendment</u> passed out of House Housing on Tuesday (<u>staff summary</u>)
- <u>HB 5019</u> and <u>the -3 amendment</u> fully funds the Governor's Homelessness State of Emergency (\$130 million), provides \$27 million in additional funding to address homelessness in 25 rural counties, among other investments





AFFORDABLE RENTAL HOUSING

OHCS Affordable Rental Housing Bills

- <u>SB 225</u> OHCS PAB Bill. PH: <u>2/6</u> Currently working with Oregon State Treasury, -2 amendment
- <u>HB 2761</u> will have a -1 amendment duplicating OHCS' <u>LC 554</u>. House Housing PH: <u>3/7</u>

House Bills

- <u>HB 2001</u> Intersections with affordable rental housing work: Oregon Housing Needs Analysis (<u>HB 2889</u>), modular housing (\$20M), predevelopment for middle income (\$3M, not OHCS), ag housing (\$5M, not OHCS)
- <u>HB 2465</u> OAHTC expansion to Limited Equity Co-Ops. House Housing WS: <u>2/21</u>
- <u>HB 3138</u> DAS, Regional Rural Revitalization Strategies Consortium on housing. House Housing WS: <u>2/21</u>
- <u>HB 2983</u> DLCD & OHCS funds to support manufactured dwellings and parks. House Housing WS: <u>2/21</u>
- <u>HB 2754</u> Housing for Seniors. House Housing <u>3/2</u>
- <u>HB 2984</u> Commercial conversion to workforce housing in UGB. House Housing PH: <u>3/2</u>
- <u>HB 2260</u> SDC study bill. <u>3/9</u>

- <u>SB 46</u> Senior Cottage Clusters. Senate Housing PH: <u>2/20</u>
- <u>SB 132</u> AWHTC sunset extension. Senate Natural Resources PH: <u>2/13</u> WS: <u>3/1</u>

HOUSING STABILIZATION

OHCS Housing Stabilization Bill

 <u>SB 893</u> – Placeholder for HB 2100 Taskforce recommendation & other needed changes. Introduced as a Senate Committee bill. Amendments to come.

House Bills

- <u>HB 2001</u> youth experiencing homelessness EHA focus (via HB <u>2454</u> & <u>2456</u>), eviction notice & timeline changes (via <u>SB 799</u>). EHA Youth Funding in HB 5019: \$5.2M
- <u>HB 3056</u> Technical fixes to Residential Heat Pump Program at ODHS & Cooling Resource website at OHCS <u>PH: 2/27</u> in House Climate, Energy & Environment
- <u>HB 3166</u> Requires State Department of Energy, in consultation with OHCS, to establish whole-home energy savings program and high-efficiency electric home rebate program, or "one stop shop" PH: <u>2/22</u> in House Climate, Energy & Environment

Senate Bills

- <u>SB 603</u> Establishes People's Housing Assistance Fund Demonstration Program, administered by ODHS, to provide 12 monthly payments of \$1,000 to individuals who are experiencing homelessness, at risk of homelessness, severely rent burdened or earn at or below 60 percent AMI. Senate Housing PH: <u>2/27</u>
- <u>SB 893</u> Prohibits landlords from denying application for tenancy based on certain criteria, driver's license possession, for Ukranian refugees WS: 3/1 ; Referred to House Vets, Emerg. Prep., & World Affairs



HOMEOWNERSHIP

OHCS Homeownership Bill

 <u>HB 3151</u> – Manufactured Housing policy bill, including Dispute Resolution Advisory Committee extension. <u>PH 3/2</u> in House Housing

House Bills

- <u>HB 3092</u> Creates a residential property wholesaler registry. <u>PH 2/21</u> <u>WS 3/9</u> in House Housing
- <u>HB 2983</u> Funding DLCD and OHCS to support manufactured homes and manufactured home parks. <u>WS 2/21</u> in House Housing

Senate Bills



<u>SB 937</u> – Creates a low interest loan fund for purchasers of homes in Community Land Trusts and other shared equity models. <u>PH 3/1</u> in Senate Housing

DISASTER RECOVERY & RESILIENCE

OHCS Disaster Recovery and Resilience Bill

• <u>HB 3215</u> – Expands OHCS construction authority to allow for direct contracting as it pertains to disaster recovery and creates a new account related to disaster recovery funding. <u>PH 3/7</u>
