HOUSING STABILIZATION: MARCH 2-16

House Bills

- <u>HB 2001</u> youth experiencing homelessness EHA focus (via HB <u>2454</u> & <u>2456</u>), eviction notice & timeline changes (via <u>SB 799</u>). EHA Youth Funding in HB 5019: \$5.2M WS: W&M Sub 3/7 & Full 3/10 House Floor Vote: 3/15
- <u>HB 3125</u> Establishes state water & sewer assistance program (similar to LIHWA) WS: 3/14 in House Ag, Land Use, Natural Resources and Water
- HB 3056 Technical fixes to ODHS Residential Heat Pump Program & OHCS Cooling Resource website WS: 3/13 in House Climate, Energy & Environment
- <u>HB 3166</u> Requires State Department of Energy, in consultation with OHCS, to establish whole-home energy savings program and high-efficiency electric home rebate program, or "one stop shop"
 - PH: 2/22 in House Climate, Energy & Environment
- <u>HB 2680</u> Requires landlord to refund screening charge within 14 days if the landlord fills the unit before screening applicant, or hasn't screened applicant. <u>PH: 3/14</u>
- HB 3237 Allows local governments to adopt maximum applicant screening charges PH: 3/14
- <u>HB 3166</u> Requires ODOE, OHCS and partners to coordinate "one-stop-shop" for energy resources & programs WS: 3/13 in House Climate, Energy & Environment
- <u>HB 3209</u> \$10M to OHCS to establish an veterans emergency housing program <u>PH: 3/7</u> in House Vets & Emerg. Management

- <u>SB 600</u> Allocates \$4.98M to Higher Education Coordinating Commission (HECC) to distribute to Oregon Office for Comm. Dispute Resolution at University of Oregon for mediation services <u>PH: 3/9</u> in Senate Ed.
- <u>SB 241</u> Requires state agencies to inform & request a resident to apply for assistance/benefits available from funded federal programs before providing similar assistance/benefits through a program that uses resources from the state <u>PH: 3/8</u> in Senate Human Services
- SB 1069 Allows electronic delivery of written notice to landlord or tenant & return of rent or security deposit via electronic means PH:

OHCS Housing Stabilization Bill

• <u>SB 893</u> – Placeholder for HB 2100 Taskforce recommendation & other needed changes. Introduced as a Senate Committee bill. Amendments to come. PH & Possible WS: 3/22

House Bills

• <u>HB 3462</u> – Requires OEM to provide emergency housing to displaced individuals in compliance with fair housing laws & to offer comparable resources to individuals who may be inelgibile for federal resources due to their immigration status PH: 3/21

- SB 919 Placeholder for amendments in SB 847 PH: 3/20
- <u>SB 600</u> Allocates \$4.98M to Higher Education Coordinating Commission (HECC) to distribute to Oregon Office for Comm. Dispute Resolution at University of Oregon for mediation services WS: 3/28 in Senate Ed.





HOMEOWNERSHIP

OHCS Homeownership Bill

• <u>HB 3151</u> – Manufactured Housing policy bill, including Dispute Resolution Advisory Committee extension. WS 3/14 in House Housing

House Bills

- <u>HB 3010</u> Limits the amount allow for the mortgage interest deduction, would direct increase revenue to first time homeownership programs. <u>WS 3/21</u> in Joint Tax
- HB 3487 Directs OHCS to create a financial education curriculum for new homebuyers. PH 3/16 in House Housing
- HB 3488 Allocates funds to OHCS for Down Payment Assistance (DPA), as well as to BOLI for fair housing. PH 3/16 in House Housing
- HB 3492 Creates a pilot Special Purpose Credit Program. PH 3/16 in House Housing Senate Bills
- SB 847 Omnibus bill for many concepts, removes requires that CLT subdivisions form HOAs. PH
 3/15 in Senate Housing
- <u>SB 936</u> Allocates funding to affordable homeownership development. <u>PH 3/13</u> in Senate Housing
- SB 937 Creates a low interest loan fund for purchasers of homes in Community Land Trusts and 3/16/20/20 shared equity models. PH 3 WEETIN Separate Housing L





DISASTER RECOVERY & RESILIENCE

OHCS Disaster Recovery and Resilience Bill

• <u>HB 3215</u> – Expands OHCS construction authority to allow for direct contracting as it pertains to disaster recovery and creates a new account related to disaster recovery funding. <u>WS 3/21</u> in House Housing

Senate Bills

• <u>SB 1012</u> – Freezes assessed value for homes destroyed in the 2020 Labor Day Wildfires PH 3/15 in Senate Natural Resources
