# 2023 Legislative Session Digest

Prepared by Oregon Housing and Community Services Government Relations Section



During the 2023 Legislative Session, the Oregon Legislature continued the trend of steady housing investments to address the needs of Oregonians across the continuum during the 2023-25 biennium (July 2023 –June 2025), allocating \$1.14 billion. As we deploy these resources, Oregon Housing and Community Services (OHCS) looks forward to working with our partners to turn these investments into meaningful progress.

Along with the historic investment level, Oregon saw a large number of policy concepts related to addressing our state's housing needs. This digest reflects the bills that OHCS staff tracked to understand their impact on the agency, our partners, and Oregonians. This list is by no means exhaustive of all legislation introduced and considered during the 2023 regular session. Rather, it serves as a reference document for the work and ideas put forward during the 2023 Legislative Session impacting the housing policy landscape. ## **Investment Digest**

OHCS received a historic \$1.14 billion from the Legislature this biennium for emergency response and supply-side solutions. Below is a summary of the investments found in SB 5511, HB 5006, HB 3395, HB 5030, HB 2001, HB 5019, and others that allocated resources to agencies to address housing issues. #### **Bond Investments**

- \$600 million to develop new affordable homes with Local Innovation Fast Track (LIFT) Rental and Homeownership and Permanent Supportive Housing programs (HB 5005)
- \$450 million per calendar year of federal Private Activity Bonds to OHCS to support the development of affordable housing (HB 5005)
- \$500 million in Direct Revenue Bonds and \$1.3 billion in Pass-Through Revenue Bonds to support affordable housing and homeownership lending (HB 5005)
- \$50 million to preserve and improve existing affordable homes, prevent rent increases in affordable housing, and preserve manufactured home parks (HB 5030)
- Investments outside of OHCS
  - \$50 million for early childcare infrastructure grants and loans via Business Oregon
  - \$4.9 million to Homes for Good for Naval Reserve Affordable Housing & Early Learning Project via the Department of Administrative Services
  - \$5 million to Port of Portland's Building Innovation Hub (Terminal 2 Mass Timber Factory) via the Department of Administrative Services
  - \$5 million to Redmond for the Northpoint Vista Mixed-Income Neighborhood
     Project via the Department of Administrative Services

#### **General Fund Investments**

- Affordable Rental Housing Investments
  - \$20 million to develop the Affordable Housing Loan Guarantee Fund to guarantee the repayment of loans to finance the construction of affordable and moderate-income households (HB 3395)
  - \$20 million to establish modular housing grant funding to begin or expand the production capacity of modular housing (HB 2001)
  - \$10 million to establish grant funding for community housing supporting agricultural employees (HB 3395)
  - \$9.7 million for early-stage, predevelopment costs for affordable housing developments that will support streamlining the application process (SB 5511)
  - \$4 million to establish a PSH Risk Mitigation Fund to stabilize operating costs and support the longevity of PSH developments (SB 5511)

- \$3 million to create a credit against income taxes for selling publicly supported housing to retain the housing as affordable (HB 2071)
- Homeownership Investments
  - \$7.5 million for down payment assistance for homebuyers tied to OHCS lending products, Flex Lending and Oregon Residential Bond Loan Program (SB 5511)
  - \$7.5 million to capitalize a new low-income mortgage loan fund to be run by the Network for Oregon Affordable Housing (HB 3395)
  - \$5 million to fund the development of homes for purchase, to be used with LIFT Homeownership (HB 5506)
  - \$2.5 million for the Manufactured Home Replacement Program (MHRP) to help low-income Oregonians replace older or unsafe manufactured homes, preserving an essential part of Oregon's affordable homeownership stock (SB 5511)
  - \$2.5 million for Foreclosure Avoidance Counseling (FAC) (SB 5511)
- Homelessness Emergency Response Investments
  - Inside of the Executive Order 2023-02 Regions
    - \$85.2 million to create 600 new shelter beds and rehouse 1,200 households by Jan. 10, 2024 (HB 5019)
    - \$45.8 million to continue operation of the 600 new shelter beds for remainder of 2023-25 biennium (SB 5511)
    - \$39.7 million to maintain rehousing efforts for 1,200 households through rental assistance and other services for remainder of 2023-25 biennium (SB 5511)
    - \$17.5 million to maintain unit access for 1,200 households that were rehoused through block leasing and other supports for remainder of 2023-25 biennium (SB 5511)
    - \$2.3 million to maintain local service provider staffing for remainder of 2023-25 biennium to support outreach to people experiencing homelessness and navigation to shelter (SB 5511)
  - Inside the Rural Oregon Continuum of Care
    - \$39 million in a Special Purpose Appropriation (SPA)<sup>1</sup> for long-term rental assistance, 25% of funds set aside for culturally specific organizations (HB 5506)
    - \$27.4 million to create 100 new shelter beds and rehouse 450 households by June 30, 2025 (HB 5019)

- o Statewide
  - \$55 million, 30% of funds set aside for culturally specific organizations, to prevent homelessness for remainder of 2023-25 biennium (SB 5511)
  - \$33.6 million to prevent homelessness for 8,750 households by Jan. 10, 2024 (SB 5511)
  - \$4.1 million to support OHCS & Oregon Department of Emergency Management (ODEM) emergency response capacity (HB 5019)
- Other Housing Stabilization Investments
  - \$24.1 million to maintain sheltering operations for shelters, navigation centers, and Project Turnkey sites (SB 5511)
  - \$10 million to the nine sovereign Tribes in Oregon for homeless services while focusing on the unique barriers faced by Tribal communities (HB 5019 and SB 5511)
  - \$6 million to provide support and resources to Oregon tenants through direct funding to Community Alliance of Tenants, Springfield Eugene Tenant Association, and Oregon Law Center's Eviction Defense Project (SB 5511)
  - \$5 million in the Emergency Housing Account (EHA) to address youth homelessness (HB 5019)
  - \$1 million in EHA funds to provide services for pets of people experiencing homelessness (SB 5511)
- \$1.7 million to advance language access across OHCS programs (SB 5511)
- OHCS received additional resources to pay for debt service related to bonding investments spanning many biennia, staffing, and other spending authority (HB 5506).
- \$50 million was allocated to the Emergency Board to address emergent matters during the interim between legislative sessions (HB 5506).

  - Department of Justice (DOJ)
    - \$6 million for crime victims and survivor services division to assist victims of domestic violence or sexual assault with housing assistance (HB 5506)
  - Department of Administrative Services (DAS)
    - \$5 million for Metro's Transit-Oriented Development Program (HB 5506)
    - \$5 million to provide grants to councils of governments and economic development districts to support housing and community development capacity within cities, counties, and the nine federally recognized Tribes in Oregon (HB 3395)

#### **Budget Notes**

OHCS received the Budget Notes below in SB 5511.

• Expenditure and Outcome Information: Oregon Housing and Community Services is directed to maintain and update – at least semi-annually – data dashboards or other publicly accessible information that provides information on outcomes, and information on state investments provided to the department. The information should include the amount of the state investment compared to how much of the investment has been spent down and should compare state investments to department funding from other sources. The information should be available by program, date, county or region, and local service provider, as applicable. This information shall be available and maintained on the agency's website. At least once per year, the agency shall report to the Joint Committee on Ways and Means on progress to date in expending appropriated funds, and on related outcomes for homeownership, affordable rental housing and homeless services that include the number housing units funded, and number of households served through the department's programs, as applicable.

 Agency Appropriation Structure: Oregon Housing and Community Services is directed to work with the Legislative Fiscal Office and Chief Financial Office to establish a more detailed appropriation structure for its primary biennial budget bill that more accurately and transparently reflects amounts budgeted for the agency's primary areas of investment. The changes shall be incorporated into the primary budget bill for the department that is submitted for the 2025 regular Legislative Session. The bill shall include amounts by applicable fund type, including General Fund, Other Funds, Federal Funds, and Lottery Funds, for the following agency summary cross reference programs: Housing Stabilization; Project-Based Rental Housing Assistance; Multifamily Rental Housing Programs; Single-Family Housing; Disaster Recovery and Resiliency; Central Services; Bond Activities and Debt Service; and Capital Construction.

HB 5506 included Budget Notes for other agencies, some of which may interest OHCS partners.

- The Department of Human Services is directed to present to the Human Services Subcommittee of the Joint Committee on Ways and Means during the 2024 regular legislative session on (1) the status of efforts to transition the current caseload of 300 individuals (as of June 5, 2023) into community-based housing and wraparound services, (2) the number of similarly situated individuals who have arrived in Oregon in need of like services, and (3) efforts to connect those individuals with community-based organizations and resources.
- By Feb. 1, 2024, the Department of Administrative Services shall submit a report to the Joint Committee on Ways and Means and an appropriate committee or interim committee of the Legislative Assembly with recommended solutions and a timeline for how to insure against liability arising out of the provision of services pursuant to ORS 161.365 and 161.370 for the purposes of community restoration or to restore fitness to proceed, or other behavioral health services required under a court order. The recommended solutions may include establishing an insurance pool for counties, community mental health programs, and providers.
