### **Overall Progress Narrative:**

Q4 2023 was an active quarter for OHCS's CDBG-DR funding. Recovery programs have continued to steer toward launch, with many important milestones taking place within the quarter:

- Signed agreements with experience local partner organizations to perform outreach efforts with survivors.
- Continued drafting policy for HARP, Housing Recovery Services and IHA. All three of these have final drafts as of January 2024.
- · Completed a nonsubstantial Action Plan Amendment to better align requirements with policy and provide clarity to the public.
- · Continued preparation for a January Call Center launch so applicants have immediate phone, email, and SMS resources
- · Provided more than a dozen trainings to subrecipient partners on HUD requirements, federal rules, and best practices for managing federal funding.
- Refined our construction management process to better support applicants by having the state manage construction efforts.
  - · Completed our Tier I environmental review for both HARP in all eight impacted counties.
- Continued coordination with federal and state partners to ensure the HARP environmental process will be as streamlined as possible.
- Published a Compliance and Monitoring Manual, a Subrecipient Manual, and revamped the Re.Oregon.Gov website. Q1 2024 is anticipated to see many additional milestones as HARP continues to approach a launch date. OHCS is working closely with local partners to continue outreach work to prepare applicants for the program and will continue preparing intake subrecipients with training, resources, and guidance in the coming months.

As the lead agency for administering the State of Oregonâ¿¿s CDBG-DR and CDBG-MIT funds, OHCS Disaster Recovery and Resiliency division leads all monitoring efforts to ensure that OHCS staff directly administering programs, Subrecipients, and Subgranteesâ¿, and ReOregon Program Staff comply with all regulations governing administrative, financial, and programmatic operations and that they achieve performance objectives on time and within budget.

Within DRR, monitoring is the responsibility of the Operations and Compliance Manager and Compliance staff with oversight by the Chief Contracting and Compliance Officer.

#### State-funded Recovery Work:

In addition to undertaking program and policy development for CDBG-DR funds, DRR staff programmed \$150 million in state funding to support the recovery of wildfire-impacted households and communities. Results from that funding include:

- Rent assistance, purchase and repair grants and flexible assistance provided to 1,146 wildfire-impacted individuals through the Wildfire Recovery and Resilience Account (WRRA) \$35.3 million allocation. WRRA funding also helped 867 individuals achieve permanent housing.
- The development of over 400 permanent homes for wildfire survivors (another 569 affordable housing units with a wildfire preference and funded with tax credits and other state funding will be made available).
- Funding for the redevelopment and preservation of three destroyed manufactured dwelling parks in Jackson and Lane
- Largely thanks to the WRRA program, when FEMA closed down their Direct Housing Mission in spring 2023, 200 survivors had moved to temporary or permanent housing and no survivor households were forced out of FEMA shelters.
   Direct county allocations totaling \$19 million to fund community-driven projects, home replacement grants and land

We are currently working on 8 state projects that include preserved manufactured home parks, stick built town homes, an apartment complex, single family lots, and a tiny home village. We have a total of over 400 units that are currently being developed for wildfire survivors.
